Something to do this week! Consider how you keep children safe when eating

Tragically, a child dies in the UK every month from choking and hundreds more require hospital treatment. It can happen quickly, and it can happen to any child regardless of age.

The Early Years Foundation Stage Framework makes it clear that children must always be closely supervised whilst eating and that this means they should be in sight **and** hearing of an adult.

Food safety - Help for early years providers - GOV.UK (education.gov.uk) includes

important messages around the preparation of foods and links to useful resources regarding keeping children safe whilst eating.

The Food Standards Agency have created a useful poster to display where food is prepared and served to children as a helpful reminder of how to minimise the risk of choking. You can download the poster here: Choking hazards poster

Let's Celebrate!

This week we are shouting a fabulous Wednesday Well Done to three more settings in Lancashire who have recently has their Ofsted inspection reports published

Little Stars Day Nursery in Preston were recognised in their report for knowing their children well. The inspector noted : 'Staff are welcoming and know children well. They use children's existing interests to engage their attention and build on what they already know and can do. Staff make sure each child and their family feels valued and included'. Hannah Topping shared that the inspection was really good and that her learning walk went well. She said that they are having a garden make-over and the inspector was impressed with the environment.

Playdor Nursery also in Preston are celebrating their positive inspection outcome. Deputy Manager Harriet Mahon shared that the inspection went well and the inspector put them at ease and was really easy to talk to. The inspector was having an inspection herself on the day. Sharon, the manager did most of the inspection but Harriet as a Deputy she was also actively involved. The inspector captured that : 'At the heart of this caring setting is the understanding that building warm and trusting relationships supports children to progress well. Welcoming and friendly staff allow children to separate confidently from their parents and carers. Staff provide a calm and enticing environment for children to develop their individuality.'

Whitworth Playgroup in Rossendale have recently had their inspection report published. Manager Liz Hughes said that they are really pleased with their report. The inspector was excellent and she was very reassuring. She gave feedback during the morning which helped the staff to relax. The inspector remarked on the kindness from the children within the setting towards each other and that every child was busy and involved at their play. The inspector noted how: 'Communication and language is well supported in the playgroup. Staff use clear words with children and hold conversations to deepen their understanding of speech. Additionally, staff use image boards around the playgroup to help spark discussions from children.'
