Something to do this week – informing Ofsted of events



Ofsted registered providers are required to report specific incidents and events to them. You may either use the 'report an incident' form (link below) or email Ofsted (using an email address they have registered for your setting) ensuring that you include your Unique Reference Number (URN), name and setting address.

Here are some of the most common things to report

Allegations of harm or abuse: you must report any allegations made about anyone who works or lives at premises where childcare takes place, even if the allegation is made about an event that did not happen at the setting or in setting hours.

Disqualification: all adults working or living on the premises MUST be DBS checked. If the registered provider, an employee or someone living or working on childcare premises becomes disqualified from being able to live or work on the premises (DBS disqualification) then you must report this to Ofsted.

Suitability: if someone who works or lives on the premises where childcare takes place is involved in an event or there are any changes that may affect their suitability such as changes to their health, involvement with police or social services, then you must inform Ofsted.

Changes to registration: you must inform Ofsted if there are changes to your registration. This includes changes to the legal entity (e.g. becoming a limited company), moving premises, making changes (including extensions) to the property, building works or other changes to the premises. If there is a change of management within a setting, changes to who lives or works on childminding premises or a change to the committee (if relevant) then you must inform Ofsted of a change to your initial registration. If there are changes to your registration relating to opening days or times you must also send in details. If there are any planned or unplanned closures, you must also let Ofsted know as soon as possible and always within 14 days.

Safety of premises or quality of childcare: you must inform Ofsted if there are any events that affect the condition of the premises or the quality of the care provided. Examples of this may be fires, floods, unsafe gas appliances, no running water or carbon dioxide detection.

Child incidents: if a child dies whilst in your care you must report it. You must also report any serious accident, injury or illness affecting the child while they are being looked after. This includes food poisoning affecting at least two children.

Death or serious incident involving others: if anyone else besides the children on the premises, dies, has a serious accident, or a serious injury, you must report this to Ofsted.

Other incidents: you must inform Ofsted if a child leaves the premises unattended or is lost when on outings. You must also inform Ofsted if there is a serious complaint regarding your service which is made directly to you.

This week we are shouting a fabulous Well Done to three more settings in Lancashire who have recently had their Ofsted inspection reports published.

Sandcastles in Morecambe shared that their inspection went well. Helen O'Hagan Nursery Director shared, 'Our inspector made a noticeable effort to put

staff at ease, he checked in with me at points through the day to ensure I was happy with his conduct. He prioritised spending time with children although he also made time for all the manager questions and due diligence. What helped me most was that I had used the grade descriptors to make notes about what we are proud of and wanted to draw his attention to. I checked these off during the learning walk and as the day progressed. Their inspection report captures how

Leaders have devised a curriculum that provides children with the knowledge and skills that they need to get ready for school and beyond. Staff consider children's interests alongside their next steps in learning when they plan activities.

Ashbourne Day Nursery in Ingol have had their report published, in which it notes Children demonstrate impressive skills in literacy, communication and mathematics. It is clear children feel challenged by their learning, and those who are moving to primary school are well prepared.

Deputy Manger Louise Poulton said that the inspector was lovely and they had a really good day.

ABC Treehouse in Staining shared their inspection experience with us. Manager Caroline Rutherford said that the whole experience was a positive one and that the inspector was very reassuring to the staff and gave plenty of feedback. Their inspector noted how

The provider supports staff effectively in their professional roles and personal lives. They target professional development opportunities to enhance teaching and to benefit the children attending.

Thank you so much to all of you who attended the Engagement Events. Please find attached the slides shared at the event. If you were not able to attend, we would be very grateful if you could read through the two sets of slides attached and have your say by completing the survey at the end.

The DFE has allocated money to Local Authorities through the HNPCA (High Needs Provision Capital Allocation). There are strict guidelines for what this fund can be used for. Lancashire currently has around £57million from this fund. Some projects are already underway and we are now seeking feedback on the proposed plan for how the remainder of this money (and any further DFE HNPCF allocation) should be used over the next 3 to 5 years.
