NOTICE OF PROPOSAL LANCASHIRE COUNTY COUNCIL (CAMPION DRIVE, HAWTHORN CRESCENT, PARKTHORN ROAD, THORNPARK DRIVE AND THORNTREES AVENUE, LEA, PRESTON CITY) (REMOVAL AND INTRODUCTION OF BUS STOP CLEARWAYS)



NOTICE IS HEREBY GIVEN that Lancashire County Council propose the following:

- 1) Remove bus stops in the following locations:
 - a) Hawthorn Crescent, Preston, the west side, from a point 23 metres south of its junction with the centreline of Daisy Croft;
 - b) Hawthorn Crescent, Preston, the west side, from a point 70 metres north east of its junction with the centreline of Stoney Butts;
 - c) Campion Drive, Preston, the south west side, from a point 27 metres north west of its junction with the Centreline of Parkfield Crescent.
- 2) Introduce a Bus Stop Clearway at any time (the effect of which will be to prohibit the stopping of vehicles) in the following lengths of road:
 - a) Thorntrees Avenue, Preston, the east side, from a point 28 metres south of its junction with the centreline of Blackpool Road for a distance of 15 metres in a southerly direction;
 - b) Thornpark Drive, Preston, the south side, from a point 13 metres west of its junction with the centreline of Sutton Drive for a distance of 27 metres in a westerly direction;
 - c) Hawthorn Crescent, Preston, the west side, from a point 5 metres north of its junction with the centreline of Daisy Croft for a distance of 17 metres in a northerly direction;
 - d) Hawthorn Crescent, Preston, the south side, from a point 23 metres west of its junction with the centreline of Stoney Butts for a distance of 25 metres in a westerly direction;
 - e) Parkthorn Road, Preston, the south west side, from a point 6 metres south east of its junction with the Centreline of Parkfield Crescent for a distance of 27 metres in a south easterly direction.

Statement of Reasons

It is proposed to introduce Bus Stop Clearway box markings on Thorntrees Avenue, Thornpark Drive, Hawthorn Crescent and Parkthorn Road, Lea, Preston.

The purpose of these proposals are to allow for effective enforcement to prevent vehicles from creating problems with bus manoeuvres by parking obstructively on the road where the Bus Stops are located. The proposals seek to improve bus services as part of the wider Bus Services Improvement Plans (BSIPs) and allow the safe passage and manoeuvring of the local bus.
