

**NOTICE OF PROPOSAL**  
**LANCASHIRE COUNTY COUNCIL**  
**(SIDGREAVES LANE, PRESTON, PRESTON CITY)**  
**(REMOVAL AND INTRODUCTION OF BUS STOP**  
**CLEARWAY)**



**NOTICE IS HEREBY GIVEN** that Lancashire County Council propose the following:

- 1) Remove a bus stop clearway in the following locations:
  - a) Sidgreaves Lane, Preston, the north east side, from a point 78 metres south east of its junction with the centreline of Buckthorn Drive for a distance of 15 metres in a south easterly direction;
  - b) Sidgreaves Lane, Preston, the south west side, from a point 62 metres south east of its junction with the centreline of Buckthorn Drive for a distance of 15 metres in a south easterly direction.
- 2) Introduce a Bus Stop Clearway at any time(the effect of which will be to prohibit the stopping of vehicles) in the following locations:
  - a) Sidgreaves Lane, Preston, the north east side, from a point 66 metres south east of its junction with the centreline of Buckthorn Drive for a distance of 27 metres in a south easterly direction;
  - b) Sidgreaves Lane, Preston, the south west side, from a point 62 metres south east of its junction with the centreline of Buckthorn Drive for a distance of 27 metres in a south easterly direction.

**Statement of Reasons**

The purpose of the Bus Stops clearway is to support the upgrade of the existing bus stops to a quality bus stop. This is to allow the buses to pull in and out safely and allow effective enforcement.

The proposals are being pursued as part of a Section 278 agreement under the Highways Act 1980 and are linked to planning permission 06/2023/0830 102no. affordable dwellings with access from Sidgreaves Lane combined with highway and footway improvements.

These proposals are being funded fully by the developer and will allow safe boarding and alighting of passengers allowing buses to pull in and out safely and facilitate effective enforcement.
