PRESTON CITY) (REMOVAL AND INTRODUCTION OF BUS
STOP CLEARWAYS)



NOTICE IS HEREBY GIVEN that Lancashire County Council propose the following:

- 1) Remove a bus stop clearway in the following lengths of road:
 - a) Fylde Road, Preston, the north side, from a point 19 metres west of its junction with the centre line of Dewhurst Street, for a distance of 37 metres in a westerly direction;
 - b) Tulketh Brow, Preston, the north east side, from a point 22 metres north west of its junction with Water Lane, for a distance of 23 metres in a north westerly direction:
 - c) Tulketh Brow, Preston, the south west side, from a point 39 metres north west of its junction with Water Lane, for a distance of 19 metres in a north-westerly direction.
- 2) Introduce a Bus Stop Clearway at any time (the effect of which will be to prohibit the stopping of vehicles) in the following lengths of road:
 - a) Fylde Road, Preston, the north side, from a point 20 metres east of its junction with Aqueduct Street for a distance of 38.5 metres in an easterly direction;
 - b) Tulketh Brow, Preston, the north east side, from a point 11 metres north west of its junction with the centreline of Stocks Road for a distance of 17 metres in a north westerly direction;
 - c) Tulketh Brow, Preston, the south west side, from a point 13 metres south east of its junction with the centreline of Hanbury Street for a distance of 17 metres in a south easterly direction.

Statement of Reasons

This proposal forms part of a wider package of highway improvements designed to enhance traffic flow, road safety, and active travel infrastructure. Creating or enhancing shared-use paths to promote walking and cycling. These interventions will enhance the safe and efficient movement of all road users. It is hoped that these proposals will support and encourage sustainable modes of transport, in line with both local and national transport policy objectives. The proposal includes relocating the existing bus stops. This is to allow the buses to pull in and out safely and allow effective enforcement. This will help to minimise disruption to general traffic and improve accessibility.
