# ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL (VARIOUS LOCATIONS, PRESTON AND SOUTH RIBBLE) (REVOCATIONS (SPEED LIMITS 25-26 NO1)) ORDER 202\*
