

ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL (BROCK STREET, LANCASTER, LANCASTER CITY) (PART REVOCATION, AUTHORISED TAXI RANK AND GOODS VEHICLES LOADING/UNLOADING BAY) ORDER 2012

The County Council of Lancashire ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4(2) and (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. Definitions and Interpretation

For all the purposes of this Order the terms described in this Article shall have the meanings specified:

- a) **"authorised taxi rank"** means any area of carriageway which is comprised within and indicated by a road marking, complying with diagram 1028.2 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002.
- b) **"Loading/Unloading Bay"** means the loading/unloading only bay as specified in Article 4 to this Order.
- c) **"Goods Vehicle"** means a motor vehicle or trailer construction or adapted for use for the carriage or haulage of goods or burden of any description as described in the Traffic Signs Regulation and General Directions 2002.

2. Part Revocation

That part of the "Lancashire County Council (Lancaster City Area) (On Street Parking Places, Prohibition And Restriction of Waiting) Consolidation Order 2009," Schedule 8.15 Goods Vehicle Loading and Unloading Only, Monday – Saturday 8am-6pm, Item 1, insofar as it relates to Brock Street, Lancaster, north side, from a point 7.5 metres in an easterly direction from its westerly junction with Penny Street for a distance of 31 metres in an easterly direction is hereby revoked.

3. Authorised Taxi Rank

Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform, or a civil enforcement officer, cause or permit any vehicle other than a licensed Hackney Carriage to wait between 2200 hours and 0600 hours on Brock Street, Lancaster, north side, from a point 12 metres east of the centre line of Penny Street for a distance of 31 metres in a northerly direction.

4. Prohibition of Waiting

Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform, or a civil enforcement officer, cause or permit any vehicle to wait, Monday to Saturday, 8am to 6pm, in the Loading/Unloading bay, except for a goods vehicle being used to load/unload goods, on Brock Street, Lancaster, north side, from a point 12 metres east of the centre line of Penny Street for a distance of 31 metres in a northerly direction.

5. Exceptions

Nothing in Article 3 or 4 of this Order shall render it unlawful to cause or permit any vehicle to wait at any time on any day on those lengths of road referred to therein, for so long as may be necessary to enable:-

- a) a person to board or alight the vehicle;
- b) the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following:-
 - i) building, industrial or demolition operations;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said lengths of roads;
 - iv) the laying, erection, alteration or repair in or near land adjacent to the said lengths of roads of any sewer or of any main, pipe or apparatus or the exercise of any other statutory power or duty for the maintenance and supply of gas, water or electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984;
- c) the vehicle to be used for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road;
- d) A Royal Mail liveried vehicle engaged in the collection and/or delivery of letters in accordance with the statutory provisions as defined in the Postal Services Act 2000
- e) the vehicle to be used for fire brigade, ambulance or police purposes in pursuance of statutory powers or duties.
- f) the vehicle to wait at or near to any premises situated on or adjacent to the said length of road for so long as such waiting by the vehicle is reasonably necessary in connection with any wedding or funeral.

6. Miscellaneous

The prohibition/restriction imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act or by or under any other enactment.


7. Commencement of Order
