## NOTICE OF PROPOSAL ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL (GILLIBRANDS ROAD, SKELMERSDALE, WEST LANCASHIRE BOROUGH) (PROHIBITION OF WAITING) ORDER 202\*

**NOTICE IS HEREBY GIVEN** that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to introduce a prohibition of waiting in the following lengths of road:

- a) Gillibrands Road, Skelmersdale, the north west side, from a point 63.5 meters east of its junction with the centreline of Glebe Road, then a distance of 37 metres from its junction with the centreline of C153 Gillibrands Road in a south westerly direction for a distance of 54 metres in a south westerly direction;
- b) Gillibrands Road, Skelmersdale, the south east side, from a point 228.5 metres north west of its junction with the centreline of Grimrod Place for a distance of 35 metres in a westerly direction then a distance of 41 metres in a south westerly direction;
- c) Gillibrands Road, Skelmersdale, the south east side, from a point 63.5 metres east of its junction with the centreline of Glebe Road, then a distance of 43 metres from its junction with the centreline of C153 Gillibrands Road for a distance of 50 metres in a south westerly direction;
- d) Gillibrands Road, Skelmersdale, the west side, from a point 17 metres east of its junction with the centreline of Glebe Road for a distance of 37 metres in an easterly direction then 31 metres in a south westerly direction.
