This Order is made by Lancashire County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act, 1981 ("the Act") because it appears to that Authority that The Definitive Map and Statement of Public Rights of Way for the County of Lancashire require modification in consequence of the occurrence of an event specified in Section 53(3)(b) and 53(3)(c)(i) namely the expiration of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path and the discovery by the Surveying Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, namely a public footpath.

The Authority have consulted with every local authority whose area includes the land to which the Order relates. Lancashire County Council hereby order that:

- 1. For the purposes of this Order, the "relevant date" is the 21st October 2015.
- 2. The Definitive Map and Statement of Public Rights of Way for the County of Lancashire shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as The Lancashire County Council (Ormerod Street to Gamble Road, Thornton Cleveleys) Definitive Map Modification Order 2015.

Public Footpath from a point on the corner of Ormerod Street (point A on the Order Map), running in a north westerly direction for a distance of 75 metres to pass through stone gateposts (point B on the Order Map) then in a northerly direction east of two ponds for 170 metres to point C. The route passes through gateposts at point C and then runs in a north north westerly direction for 255 metres passing through a gap in the hedge at point D, across playing fields to a fence at point E and across rough grass to exit onto Gamble Road at point F; a total distance of 500 metres. 


