#### **THE LANCASHIRE COUNTY COUNCIL (ORMEROD STREET TO GAMBLE ROAD, THORNTON CLEVELEYS) DEFINITIVE MAP MODIFICATION ORDER 2015**

The above Order, made on the 21<sup>st</sup> October 2015, if confirmed as made, will modify the Definitive Map and Statement of Public Rights of Way for the area, by adding a public footpath from a point on the corner of Ormerod Street (Point A grid reference SD 3392 4349) running in a north westerly direction for 75 metres through stone gateposts to Point B (SD 3386 4353) then in a northerly direction east of two ponds to Point C (SD 3384 4369), the route then passes through gateposts at Point C and then runs in a north north westerly direction for 255 metres to Point D (SD3381 4379), then across the playing fields to a fence at Point E (SD 3378 4391) and then across rough grass to exit onto Gamble Road Point F (SD3378 4349) for a total distance of approximately 500 metres.

**THE M6 MOTORWAY (JUNCTION 32) SOUTHBOUND**  
**CARRIAGEWAY AND M6 SOUTHBOUND LINK ROAD**  
**TO M55 LINK ROAD)**  
**(TEMPORARY PROHIBITION AND RESTRICTION OF**  
**TRAFFIC) ORDER 2015**

**NOTICE IS HEREBY GIVEN** that Highways England Company Limited (Company No. 09346363) intends to make an Order on the M6 Motorway and M55 Link Road in the Borough of Fylde in the County of Lancashire to enable replacement of the M55 parapet located above the M6 to be carried out in safety.

a) The Order will impose a 50 mph speed limit on all traffic on the following sections of the M6 Motorway:  
 i. the southbound carriageway between a point 600 metres north of Whittingham Lane Bridge to a point 500 metres beyond Fylde Higher Bridge;  
 ii. the southbound carriageway to the M55 westbound link road.

b) The Order will ban all traffic from the southbound carriageway of the M6 Motorway from the last point where the junction 32 off link road leaves the carriageway to the first point where the junction 32 on link road joins the carriageway;

c) The Order will ban all traffic from the M6 southbound to M55 westbound link road.

Prohibition (b) is expected to be in place overnight between 2200 hours and 0600 hours for a total of ten nights during a period starting on Monday 30 November 2015 and ending on Monday 14 December 2015. However, work may start and continue beyond these dates until completed.

Prohibition (c) is expected to take place overnight between 2200 hours and 0600 hours for a total of two nights during a period starting on Monday 30 November 2015 and ending on Tuesday 15 December 2015. However, work may start and continue beyond these dates until completed.

Restrictions (a) - (c) are expected to be in place continuously starting at 0600 on Monday 30 November 2015 and ending at 2200 hours on Tuesday 15 December 2015. However, work may start and continue beyond these dates until completed.

Diversion routes via alternative junctions of the M6 Motorway and local roads will be well signed.

The restrictions will not apply to emergency services or special-forces vehicles, and the prohibitions will not apply to emergency services, works, winter maintenance, or traffic officer vehicles. The prohibitions and restrictions will only apply during such times and to such extent as shall from time to time be indicated by traffic signs.
