

NOTICE OF PROPOSAL
LANCASHIRE COUNTY COUNCIL
(VARIOUS LOCATIONS, CHORLEY TOWN CENTRE,
CHORLEY BOROUGH) (BUS STOP CLEARWAYS)



NOTICE IS HEREBY GIVEN that Lancashire County Council propose to introduce a Bus Stop Clearway at any time (the effect of which will be to prohibit the stopping of vehicles) in the following lengths of road:

- 1) Lyons Lane South, Chorley, the north west side, from a point 11 metres south west of its junction with the centreline of Goring Street for a distance of 27 metres in a south westerly direction;
- 2) Lyons Lane South, Chorley, the south east side, from a point 10 metres north east of its junction with the centreline of Goring Street for a distance of 13 metres in a north easterly direction;
- 3) Union Street, Chorley, the north side, from a point 15 metres west of its junction with the centreline of Fellery Street for a distance of 27 metres in a westerly direction;
- 4) Park Road, Chorley, the south west side, from a point 23 metres north west of its junction with the centreline of Queens Road for a distance of 27 metres in a north westerly direction;
- 5) Park Road, Chorley, the south east side, from a point 63 metres south west of its junction with the centreline of Park Street for a distance of 27 metres in a south westerly direction;
- 6) Park Road, Chorley, the north west side, from a point 10 metres north east of its junction with the centreline of Millfield Road for a distance of 15 metres in a north easterly direction;
- 7) Park Road, Chorley, the south east side, from a point 22 metres north east of its junction with the centreline of Nichol Street for a distance of 17 metres in a north easterly direction;
- 8) Preston Street, Chorley, the north east side, from a point 53 metres north west of its junction with the centreline of North Street for a distance of 27 metres in a north westerly direction;
- 9) Preston Street, Chorley, the south west side, from a point 44 metres north west of its junction with the centreline of North Street for a distance of 27 metres in a north westerly direction;
- 10) Preston Road, Chorley, the south west side, from a point 61 metres south east of its junction with the centreline of Highfield Road North for a distance of 27 metres in a south easterly direction;
- 11) Preston Road, Chorley, the east side, from a point 31 metres south of its junction with the centreline of The Grove for a distance of 45 metres in a southerly direction;
- 12) Preston Road, Chorley, the west side, from a point 59 metres north of its junction with the centreline of The Grove for a distance of 27 metres in a northerly direction;
- 13) Preston Road, Chorley, the east side, from a point 11 metres south of its junction with the centreline of The Spinney for a distance of 27 metres in a southerly direction;
- 14) Preston Road, Chorley, the west side, from a point 81 metres north of its junction with the centreline of Euxton Lane for a distance of 43 metres in a northerly direction.

Statement of Reasons

The purpose of the proposals are to facilitate the safe passage of vehicles and pedestrians, providing Equality Act (2010) compliant bus stops. The introduction of Bus Stop Clearways will prevent parked vehicles from obstructing kerbside boarding / alighting and improve bus journey times and consistency.
