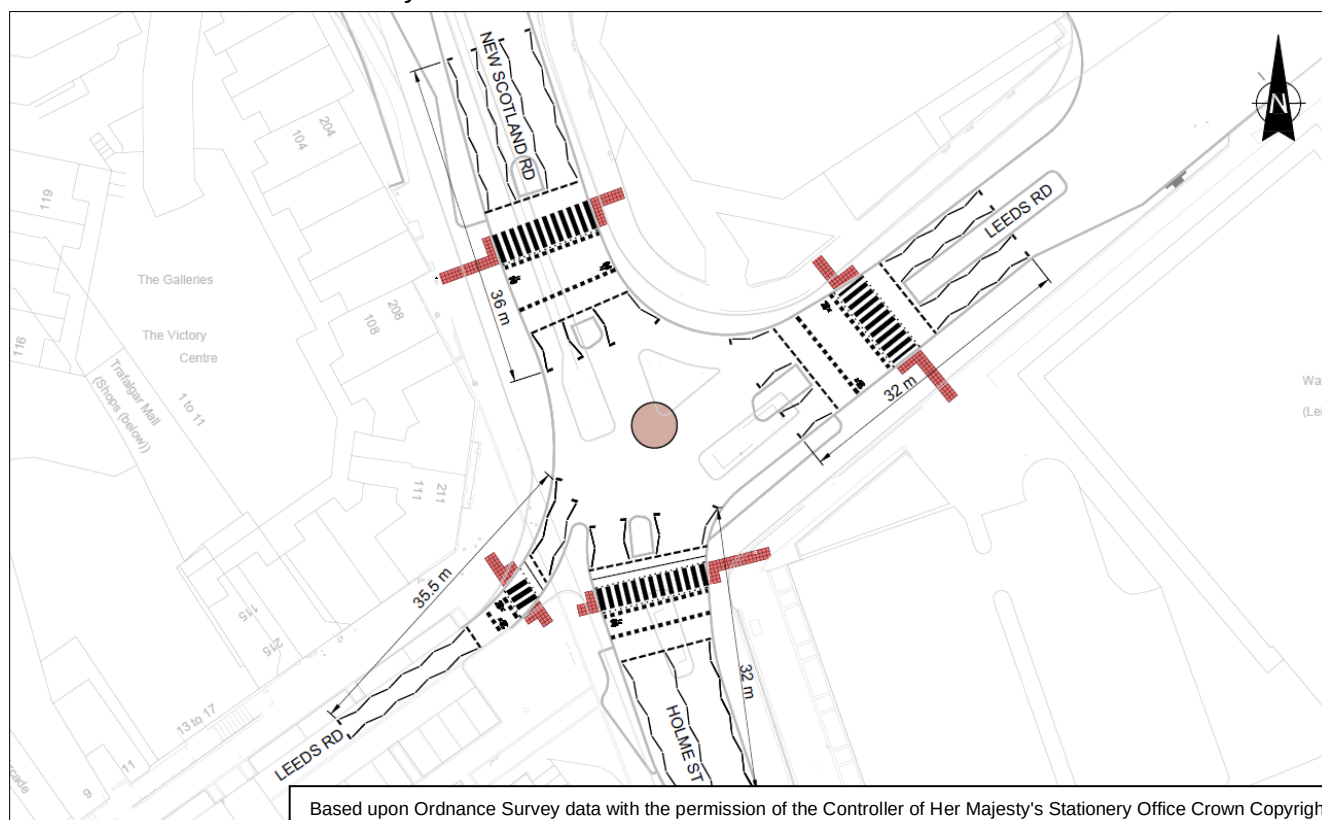
ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL

**(NEW SCOTLAND ROAD, HOLME STREET AND LEEDS ROAD, NELSON,
PENDLE BOROUGH) (PEDESTRIAN CROSSINGS)**

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above pedestrian crossing under Section 23 of the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to introduce a parallel zebra crossing in the following locations:

- a) New Scotland Road, Nelson, from its roundabout junction with Leeds Road for a distance of 36 metres in a northerly direction;
- b) Leeds Road, Nelson, from its roundabout junction with New Scotland Road/Holme Street for a distance of 32 metres in a north easterly direction;
- c) Holme Street, Nelson, from its roundabout junction with Leeds Road for a distance of 32 metres in a southerly direction;
- d) Leeds Road, Nelson, from its roundabout junction with New Scotland Road/Holme Street for a distance of 35.5 metres in a south westerly direction.



Statement of Reasons

The purpose of this scheme is to support the improved amenity in Nelson Town Centre, with improved pedestrian and cycle access and linkage across Nelson. All the proposals will work together to create a safer environment for pedestrians, cyclists, and vulnerable users. It is hoped this will give confidence to encourage more users to consider commuting via non-motorised means and this will improve health and air quality for the residents of Nelson. These proposals include pedestrian crossings to improve safety, support active travel and provide a convenient and accessible crossing points for pedestrians and cyclists.
