NOTICE OF PROPOSAL
LANCASHIRE COUNTY COUNCIL
(LEEDS ROAD AND NEW SCOTLAND ROAD, NELSON,
PENDLE BOROUGH) (BUS STOP CLEARWAY)



NOTICE IS HEREBY GIVEN that Lancashire County Council propose the following:

- 1) Remove a bus stop clearway in New Scotland Road, Nelson, the west side, from a point 30.5 metres south of its junction with the centreline of Pendle Street for a distance of 47 metres in a southerly direction.
- 2) Introduce a Bus Stop Clearway at any time (the effect of which will be to prohibit the stopping of vehicles) in the following lengths of road:
 - a) Leeds Road, Nelson, the south east side, from a point 51 metres north east of its junction with the centreline of New Scotland Road/Holme Street for a distance of 29.5 metres in a north easterly direction;
 - b) New Scotland Road, Nelson, the east side, from a point 34.5 metres south of its junction with the centreline of Pendle Street for a distance of 39 metres in a southerly direction;
 - c) New Scotland Road, Nelson, the west side, from a point 28 metres south of its junction with the centreline of Pendle Street for a distance of 34 metres in a southerly direction.

Statement of Reasons

The purpose of this scheme is to support the improved amenity in Nelson Town Centre, with improved pedestrian and cycle access and linkage across Nelson. All the proposals will work together to create a safer environment for pedestrians, cyclists, and vulnerable users. It is hoped this will give confidence to encourage more users to consider commuting via non-motorised means and this will improve health and air quality for the residents of Nelson.

These proposals include the removal and subsequent relocation of one existing Bus Stop Clearway and introduction of two Bus Stop Clearways to prioritise bus services and encourage the use of public transport.
