# Something to do this week! Make sure that you are ready if you need to recruit staff and volunteers

**Safe recruitment** is the first line of defence to prevent unsuitable people working with children and should include volunteers as well as paid members of staff including apprentices. The Early Years Foundation Stage Statutory Framework (EYFS) has been updated to strengthen this essential tool in keeping children safe. There is now a specific requirement on safer recruitment that includes details on obtaining references for new staff members and providing references for current or past staff.

Providers/Childminders who are employing assistants must obtain a reference **before** employment.

#### You should:

- not accept open references e.g. 'to whom it may concern'
- not rely on applicants to obtain their own reference
- ensure any references are from the candidate's current employer, training provider or education setting and have been completed by a senior person with appropriate authority
- not accept references from a family member
- obtain verification of the individual's most recent relevant period of employment where the applicant is not currently employed
- secure a reference from the relevant employer from the last time the applicant worked with children (if not currently working with children). If the applicant has never worked with children, then ensure a reference is from their current employer, training provider

or education setting

- ensure electronic references originate from a legitimate source
- contact referees to clarify content where information is vague or insufficient information is provided
- compare the information on the application form with that in the reference and take up any discrepancies with the candidate
- establish the reason for the candidate leaving their current or most recent post, and
- ensure any concerns are resolved satisfactorily before appointment is confirmed.

(Early Years Foundation Stage Statutory Framework)

Childminders employing new assistants will need to report recruitment to Ofsted

Childminders: report new adults in the home - GOV.UK (www.gov.uk)

If there is a change of manager or committee member at a setting, Ofsted must be informed.

Childcare providers: telling Ofsted about significant events - GOV.UK (www.gov.uk)

If new staff are being included in the ratios for the care of the children, then you must check their qualifications are relevant to be included - <a href="Check early years qualifications - GOV.UK">Check early years qualifications - GOV.UK</a> (www.gov.uk)

All people who work within Early Years are required to have DBS checks and have the right to work in the UK. Safer recruitment guidance should be followed, you can read more about this here –

Answering your questions on food brought in from home (packed lunch) policies



Since September 2025, early years providers have been required to have regard to the Early Years Foundation Stage nutrition guidance. This guidance supports settings to meet the EYFS requirement that meals, snacks and drinks provided to children must be healthy, balanced and nutritious, whether meals are served in the setting or brought from home.

This forms part of the Government's commitment to give children the best start in life by supporting healthy eating habits in the early years and helping to reduce health inequalities.

If your setting has chosen to implement a policy on food brought in from home, the Department for Education wants to hear your questions and early concerns about how implementing the policy is working in practice. This will help us understand what further information and support would be helpful for providers to get the most out of this guidance.


