
NOTICE OF MODIFICATION
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(WHEATSHEAF WAY, POULTON-LE-FYLDE, WYRE BOROUGH)
(REVOCATION AND VARIOUS PARKING RESTRICTIONS 25-26
(NO1H)) ORDER 202*



NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2 and 4 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 11 June 2025 and 09 July 2025, it is now intended to modify the proposed Order as titled above, as set out below.

- 1) Remove the limited waiting parking place for 1 hour with no return within1 hour, Monday to Saturday between 8am and 6pm in Wheatsheaf Way, Poulton-le-Fylde, the south side, from a point 8.5 metres west of its junction with the centreline of Hardhorn Road for a distance of 20.5 metres in a westerly direction.
- 2) Introduce a goods vehicle loading bay Monday to Saturday between 6am and 6pm in Wheatsheaf Way, Poulton-le-Fylde, the south side, from a point 8.5 metres west of its junction with the centreline of Hardhorn Road for a distance of 20.5 metres in a westerly direction.



Statement of Reasons

Having considered the objection and feedback, it is proposed to make the following modification to the consulted proposal The consulted changes to the parking restrictions on Wheatsheaf Way relate to the parking restrictions in this location not matching up with the TRO. The current parking restriction onsite are No Waiting 8am-10am except taxis 10am-4pm and a Loading only 8am-10am and 4pm-6pm. Wyre Borough Council have advised that the bay to the East is generally empty. To improve consistency with surrounding restrictions and better manage parking demand, we propose the following modification:

Eastern bay: Introduce a Goods Vehicle Loading Only restriction, Monday to Saturday, 6am–6pm, consistent with other loading bays nearby.

REASONS UNDER Section 1 of the RTRA

(f)for preserving or improving the amenities of the area through which the road runs.
