THE CITY COUNCIL OF LANCASTER

(LANCASTER/MORECAMBE BY-PASS ROAD)

..... (CLEARWAY) ORDER, 1994

The City Council of Lancaster (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act, 1972 with the County Council of Lancashire, in exercise of the powers to the said County Council under Sections 1 and 2 and schedule 9 of part IV of the Road Traffic Regulation Act, 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers after consultation with the Chief Officer of Police, in accordance with Schedule 9 (Part III) of the Act of 1984, hereby make the following Order:-

1. The City Council of Lancaster (Lancaster/Morecambe By-Pass Road) (Clearway) Order, 1993, is hereby revoked.
2. In this Order, the following expressions have the meanings hereby assigned to them respectively, that is to say:

 'Prohibited Areas' in relation to a specified road means all that area of a specified road which is comprised within and indicated by a road marking complying with Diagram 642 shown in Schedule 1 Part II to the Traffic Signs Regulations and General Directions 1981.

 'Specified Hours' in relation to a prohibited area means all hours on any day.

 'Specified Road' means the road in the City of Lancaster specified in the Schedule to this Order.
3. Save as provided in Article 4 of this Order, no person shall, except upon the direction of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait during the specified hours in the prohibited area in the specified road.

4. Nothing in Article 3 of this Order shall render it unlawful for a person to cause or permit a vehicle to wait in a prohibited area:
- (a) If the vehicle is being used for the removal of any obstruction to traffic; or
 - (b) if the vehicle is being used in the service of the Council, or with the permission of the Council, in exercise of statutory powers or duties and, whilst being so used in such service, it is necessary for the vehicle to wait in that prohibited area; or
 - (c) in any case, where the person in control of the vehicle is required by law to stop, or is obliged to do so in order to avoid an accident, or is prevented from proceeding by circumstances outside his control; or
 - (d) if the vehicle is being used for Police, Fire Brigade or Ambulance purposes.
5. The Council is satisfied that for facilitating the passage of vehicular traffic on the specified road, it is requisite that Section 3(1) of the Act of 1984 should not apply in relation to this Order.
6. Insofar as any provision of this Order conflicts with any provision of any other Order relating to the waiting of vehicles the provision of this Order shall prevail.
7. This Order shall come into operation on 13th June, 1994 and may be cited as "The City Council of Lancaster (Lancaster/Morecambe By-Pass Road) (Clearway) Order 1994.

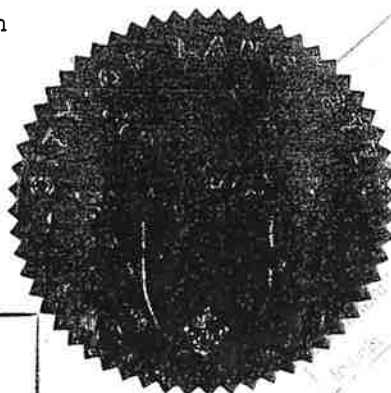
