#### Best Start in Life - new website



With the introduction of the government's new 'Giving every child the best start in life' initiative, a new website - <u>Best Start in Life</u> - has been created. This replaces several previous websites, including Better Health Start for Life, to streamline early years support under one unified brand and parent hub. The rebrand also brings together

initiatives such as Childcare Choices, Start for Life, and Little Moments Together.

In your setting, you may want to use the Best Start in Life website as a practical tool to strengthen family partnerships and signpost support. You can direct parents to sections on child development, feeding, sleep, and speech and language. There's also a Childcare Support Checker to help families understand funding options (15/30 hours, Tax-Free Childcare) and links to financial help and benefits guidance. Families can use the website to find Family Hubs for parenting classes, health advice, and community activities. They can also access resources to support their child's transition into reception.

#### **Share with parents - fake Labubu dolls**



The Chartered Trading Standards Institute (CTSI) is issuing an urgent warning about the growing number of counterfeit "Labubu" dolls being sold in the UK. The viral plush toys made popular by Chinese toymaker Pop Mart have become a global collector's craze. This popularity has fuelled a surge in fakes; many being sold by third-party sellers via online marketplaces and local shops that are breaking the law.

Trading Standards teams have seized thousands of unsafe counterfeit Labubu dolls in recent weeks. Counterfeit Labubu dolls are poorly made and unsafe. Many contain small, detachable parts

such as eyes, hands, and feet, which present a serious choking hazard to young children. Loose stitching and exposed stuffing further increase the risk of suffocation.

## Fully funded PhD Studentship on play: Applications now open



The Collaboratory Research Hub is offering a fully-funded PhD studentship titled:

### Reimagining Practices of Play: Collaborating with Nottingham communities to support children's social and educational development through curiosity-driven play

This project explores how play can be reimagined in local communities to nurture curiosity, belonging, and development in childhood, themes that are central to so much of our collective work in early childhood education and community practice.

#### The studentship includes:

- Full tuition fees
- A generous monthly stipend
- Support through NTU's collaborative doctoral training model, connecting researchers directly with communities and practice

I'd be really grateful if you could share this far and wide, with colleagues, professional networks, and anyone who might be interested in researching play at doctoral level. It's a brilliant opportunity for practitioners and researchers alike to make a real difference.

## Action: Autumn Personal Educational Plans (PEPs) for Children Looked After (CLA) in your setting

The PEP is a statutory document that MUST be completed EVERY term to ensure the regular monitoring and review of ALL Lancashire CLA. It is the joint responsibility of the social worker and the setting to produce a thorough, well thought out education plan for the term that meets the individual child's needs and moves them towards school readiness.

#### All autumn PEP meetings for CLA age to 2 years - 4 years should have taken place by now.

- Please check you Portal using this link <a href="https://professionalportal.lancashire.gov.uk">https://professionalportal.lancashire.gov.uk</a> and the email address used to register the account by the Virtual School and complete any PEPs awaiting your attention. Save the document as you go and save a PDF copy before submitting the document.
- If the PEP meeting has not been arranged, contact the child's social worker and request the meeting is arranged asap.
- If the meeting has taken place but the form has not been delegated to you, please contact the social worker to request delegation.
- All PEP documentation must be completed and submitted within 2 weeks of the PEP meeting taking place.
- Please state any concerns you have around the child's development and what is being done to support the child with in the PEP.
- Please ensure all education targets are SMART (specific, measurable, achievable, relevant and timebound) and that EYPP spending links to the child's targets (EYPP is issued for vulnerable children by the authority based on your termly head count).
- Support and new quality assurance standards can be found at <u>Personal education plans</u> (<u>PEPs</u>) guidance <u>Lancashire County Council</u>.

The EYs consultant at the Virtual School is required to attend 1 PEP meeting for all CLA due to start reception in Sept 26. Please email <a href="mayren@lancashire.gov.uk">sharie.mayren@lancashire.gov.uk</a> with the date of the next PEP for these children in your setting, or if you require any support.

Starting school is a huge moment for children, especially those who are looked-after (CLA), previously looked-after (PLA) and those who may have a social worker. These children have often experienced multiple adverse childhood experiences (ACEs) or trauma and may need more support with this important transition.

Why do we need to consider this cohort of children?

- These children are likely to be behind their peers during their early years and this gap may widen over time.
- ACEs can affect attendance, learning, behaviour and wellbeing
- In 2018, 50% of children who had a social worker (CWSW) in the last six years were able to achieve GLD compared to 72% who never had a Social Worker
- CWSW more than 3x more likely to be persistently absent from school, and 2-4 times more likely to be permanently excluded
