

**ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(WOOD LANE, HESKIN, CHORLEY AND WEST LANCASHIRE BOROUGHES)
(REVOCATION, RESTRICTED ROAD AND 40 MPH SPEED LIMIT) ORDER 2013**

The County Council of Lancashire, in exercise of its powers under Sections 82(2), 83(2) and 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, propose to make the following Order:-

1. Revocation

Hereby revoke 'The County Council of Lancaster (40 M.P.H. Speed Limit) (No. 5) Order 1968' in full.

2. Restricted Road (30mph Speed Limit will apply)

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the Restricted Road (as defined in section 82 of the Act) as set out in Schedule 1 to this Order.

3. 40mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road set out in Schedule 2 to this Order.

4. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulation.

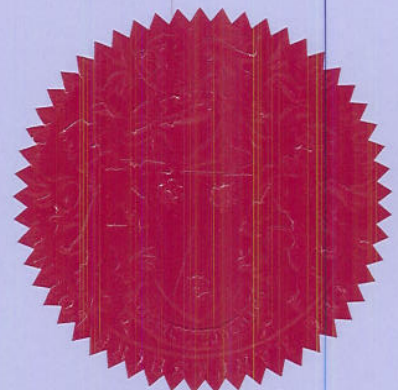
5. Commencement of Order

this order shall come into force on the 11th February 2013 and may be cited as the "Lancashire County Council (Wood Lane, Heskin, Chorley And West Lancashire Boroughs) (Revocation, Restricted Road and 40 mph Speed Limit) order 2013".

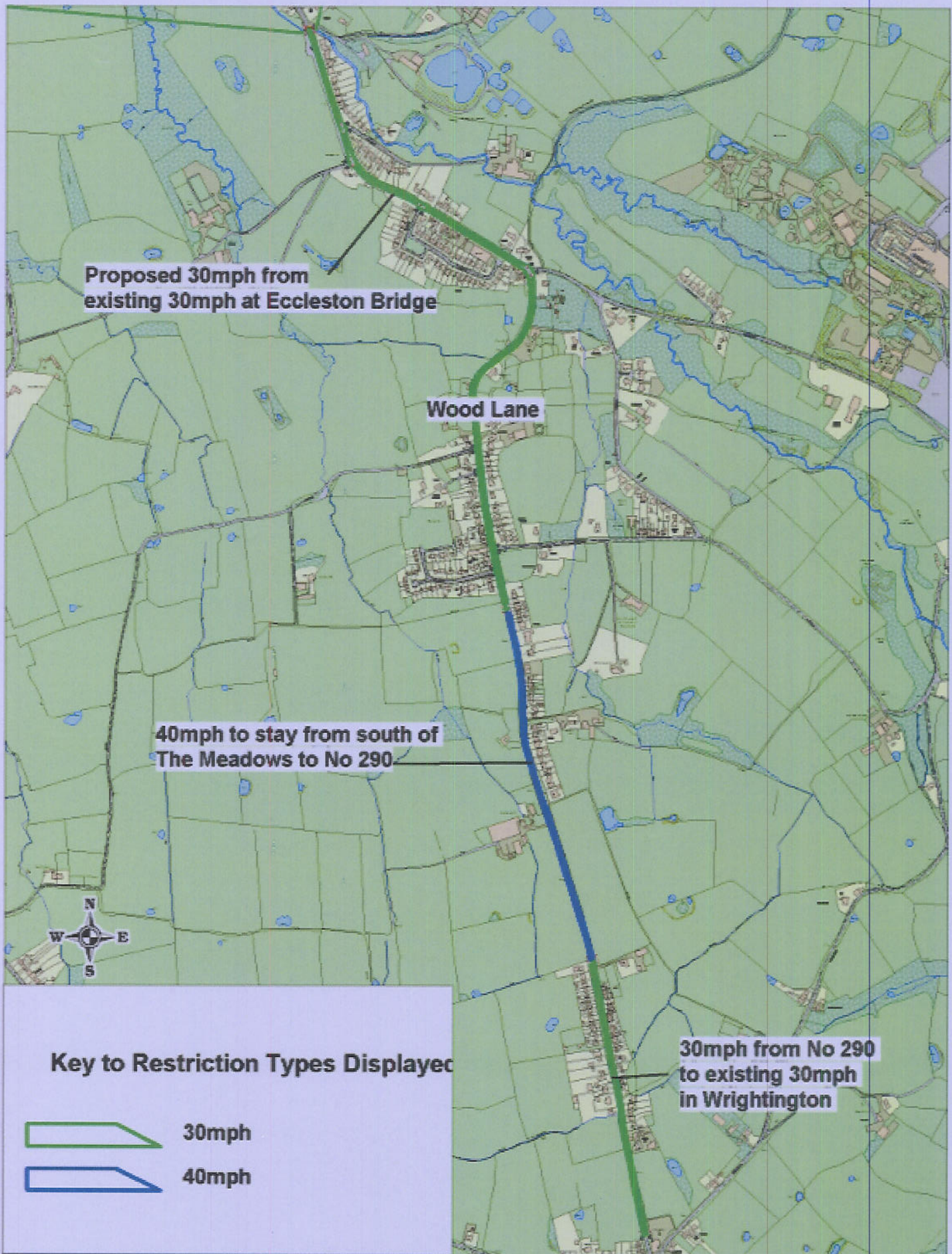
Schedule 1

a) Wood Lane, Heskin, from a point 121 metres south of the centre line of Langton Close to a point 83 metres south of the centre line of The Meadows.

b) Wood Lane, Heskin, from a point 650 metres north of the centre line of Church Lane to a point 70 metres north of the centreline of Church Lane.

Schedule 2

from a point 83 metres south of the centre line of The Meadows to a point 650 metres north of the centre line of Church Lane.
