ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL

(RHYDDINGS STREET AND UNION ROAD, OSWALDTWISTLE, HYNDBURN BOROUGH) (REVOCATION, PROHIBITION AND RESTRICTION OF WAITING AND LIMITED WAITING) ORDER 2025

NOTICE IS HEREBY GIVEN that on 28 November 2025 Lancashire County Council made the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

- 1. Revoke the following:
 - a) The "Lancashire County Council (Hyndburn Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to:
 - i. Item (214)a)(v) of Schedule 10.01;
 - ii. Item (81)(i) of Schedule 11.075.
 - b) The "Lancashire County Council (Union Road, Oswaldtwistle, Hyndburn Borough) (Revocation, Limited Waiting Parking Place And Prohibition Of Stopping On School Keep Clear Markings) Order 2017" insofar as it relates to Item d) of Schedule 2.
- 2. Introduce a prohibition of waiting in the following lengths of road:
 - a) Rhyddings Street, Oswaldtwistle, the south west side, from its junction with the centreline of Union Road for a distance of 55.5 metres in a south easterly direction;
 - b) Union Road, Oswaldtwistle, the north west side, from a point 27 metres south west of its junction with the projected centreline of Rhyddings Street for a distance of 40 metres in a north easterly direction.
- 3. Introduce a restriction of waiting Monday to Saturday 8am 6pm in Rhyddings Street, Oswaldtwistle, the north east side, from its junction with the centreline of Union Road for a distance of 21 metres in a south easterly direction.
- 4. Introduce a limited waiting parking place Monday to Saturday 8am 6pm for hour with no return within 1 hour in Union Road, Oswaldtwistle, the north west side, from a point 15.5 metres north east of its junction with the projected centreline of Rhyddings Street for a distance of 23 metres in a north easterly direction.

This Order will come into force on the 15 December 2025. Any person wishing to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the order is made, apply for the purpose to the High Court.
