ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL
(WREA GREEN AREA, RIBBY-WITH-WREA (VARIOUS ROADS), FYLDE BOROUGH)
(REVOCATION, PART REVOCATION, 20MPH, 30MPH AND 40MPH SPEED LIMIT)
ORDER 2012

The County Council of Lancashire, in exercise of its powers under Sections 82(2), 83(2), 84(1)(a) and (2) and Part IV of Schedule 9 of the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

- i. "The County Council of Lancashire (Restricted Roads) (No.1) Order 1967", is hereby revoked, in full.
- ii. "The County Council of Lancashire (Restricted Roads) (No.5) Order, 1970", is hereby revoked, in full.

2. Part Revocation

- That part of, "The County Council of Lancashire (Restricted Roads) (No.4) Order 1977" insofar as it relates to:
 - "1. That length of Station Road, B.5260 at Westby-with-Plumptons in the Fylde Borough which extends from a point 274 metres (300 yards) north of Moss Side Lane, B.5259, to a point 56 metres (61 yards) north-west of its junction with Ballam Road, a total distance measured along the said length of road of approximately 387 metres (420 yards)."

is hereby revoked.

ii. That part of, "The Lancashire County Council (A583 Kirkham Bypass and Various Roads, Westby With Plumptons and Ribby With Wrea, Fylde Borough) (Revocation, 50mph and 40mph Speed Limits and Restricted Road) Order, 1997" insofar as it relates to:

"Schedule 3 – Restricted Road (30mph Speed Limit), B5259 Ribby Road (south) from a point 187.5 metres from the eastern side of its junction with Wray Crescent to a point 218 metres east of the centre line of Wray Crescent."

is hereby revoked.

3. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on any of the roads or lengths of road set out in the schedule to this Order, located within the Wrea Green Area, Fylde Borough.

4. Restricted Road (30mph Speed Limit will apply)

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour along the following lengths of road which shall become restricted Roads (as defined in section 82 of the Road Traffic Regulation Act 1984):

 Moss Side Lane, from a point 211 metres west of its junction with The Green / Bryning Lane to a point 420 metres west of its junction with The Green / Bryning Lane, Fylde Borough;

- ii. **Station Road / Fox Lane Ends**, from a point 164 metres north of the centre line of its junction with Vicarage Close to a point 56 metres north-west of its junction with Ballam Road, Fylde Borough;
- iii. **Ballam Road**, from its junction with Fox Lane Ends to 67 metres west of the junction with Fox Lane Ends, Fylde Borough;
- iv. **Ribby Road**, from a point 647 metres east of the centre line of its junction with Wray Crescent to a point 218 metres east of the centre line of its junction with Wray Crescent, Fylde Borough.

5. 30mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour along **Bryning Lane** from a point 265 metres south of the centre line of its junction with Bryning Avenue to a point 480 metres south of the centre line of its junction with Bryning Avenue, Fylde Borough.

6. 40mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 40 miles per hour along **Ribby Road** from a point 77 metres from the edge of the carriageway at its junction with A583 to a point 647 metres east of the centre line of its junction with Wray Crescent, Fylde Borough.

7. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

8. Commencement of Order

This Order may be cited as the "Lancashire County Council (Wrea Green Area, Ribby-with-Wrea (Various Roads), Fylde Borough) (Revocation, Part Revocation, 20mph, 30mph And 40mph Speed Limit) Order 2012" and shall come into force on the 6th day of June 2012.
