Evaluating Practice

- ☐ Look at the audit tool supplied by your Childcare Development Officer alongside your Childminder Portfolio to ensure all statutory requirements are in place, or contact your Childcare Development Officer for further support

Set a reminder to review your Childminder Portfolio at least annually

- ☐ Attend the [Evaluating your Practice](#) training
- ☐ If you're employing assistants, ensure you follow safer recruitment guidance, undertake induction, regular supervisions and support their Continuous Professional Development (CPD) and knowledge of the EYFS.

Assessments

- ☐ Remember, the two year Progress Check is the only mandatory written assessment you need to complete in partnership with parents when the child is aged between 24-36 months.
- ☐ You can also borrow the Wellcomm toolkit to screen children's speech and language development. Contact your Childcare Development Officer.
