Foundation Years Ofsted reform and entitlement regulations

On 10th November 2025, Ofsted introduced their new **inspection framework** and **report cards** with a five-point grading scale following the government's commitment to remove overall effectiveness grades. These **changes to inspection outcomes** for all types of early years providers mean several early years regulations require updating so local authorities can continue to secure free childcare at safe, high-quality provision.

This includes the regulations that;

- enable (but do not require) local authorities to refuse or withdraw early education and childcare entitlements funding from providers who receive specified Ofsted grades, and,
- **require local authorities** to secure the provision of information, advice and training to early years providers registered with Ofsted that have been judged less than 'Good'.

On 3rd December 2025, the Department for Education laid a statutory instrument in Parliament updating these regulations and this is due to come into effect from 1st January 2026.

Subject to Parliament approving the changes, we can confirm the new specified grades will be as follows for inspections taking place on or after 10th November 2025.

The updated specified grades at which **local authorities** are able to **refuse or withdraw entitlements funding** will be where one or more of the following apply:

- · All entitlements where the 'Safeguarding' standards are 'Not met'
- · 30 hours childcare for eligible working families and the universal 3- and 4-year-old entitlement
- where 'Leadership and governance' has been graded as 'Urgent improvement'
- The entitlement for 2-year-olds for families receiving additional support where 'Leadership and Governance' has been graded as 'Needs attention' or 'Urgent improvement'

 The specified grades for entitlements funding **apply to all types of early years providers inspected by Ofsted**, including some independent schools. Where an independent school is inspected by an independent inspectorate, the specified grade is where either 'Safeguarding' or 'Leadership and governance' are 'Not met'.

Childminder agencies and providers registered with childminder agencies are not affected by these changes. **Local authorities** retain the ability to terminate funding for these providers where the agency is **awarded a grade of "ineffective"** in its most recent inspection report, or the agency notifies the local authority that, in its reasonable opinion, the childminder has ceased to provide childcare of satisfactory quality.

The updated specified grades requiring **local authorities** to secure the provision of information, advice and training to early years providers registered with Ofsted will be when **'Safeguarding'** standards are **'Not met'** or **'Leadership and governance'** is graded as **'Needs attention'** or **'Urgent improvement'**.

An updated version of the **Early Education and Childcare statutory guidance** will be published in early **2026**, ensuring these updates are accurately reflected in guidance for local authorities. However, **local authorities** can take action in reliance on the new specified grades from **1**st **January 2026** when the updated regulations take effect. Where providers were last inspected before 10th November 2025 under the previous inspection framework, the previous specified grades continue to apply. Should Ofsted publish a report before 1st January 2026 and the inspection took place on or after 10th November, local authorities may be able to rely on the terms of their provider agreements if they wish to take action before the updated regulations take effect.

Providers should be aware **local authorities** may need to review and update their **provider agreements** in light of these changes.

These changes are to ensure **local authorities** can continue to take action where **quality concerns** have been **identified** following an inspection and do not represent a change in policy.

With regard to entitlements funding **local authorities** have power to refuse or **withdraw funding** if they consider it appropriate, but they are not required to do so. Local authorities should work with providers to ensure children receive high-quality early education and childcare, giving the best possible start in life.

There were also **updates** made to the **Experience-Based Route eligibility criteria** to come into effect from **1 January 2026**. This is to set out the requirements for early years providers with the new Ofsted inspection framework and for independent schools inspected by an independent inspectorate. Updates on the review process for continuation of inclusion funding for childminders

Attached is a letter from the Specialist Teaching Service – Early Years Team on the key changes for review arrangements of Inclusion Funding. Any review requested will no longer be accepted by paper-based methods and the link contained in the attached letter should be used to request continuation of inclusion funding.

Action required: Autumn Personal Education Plans (PEPs) for Lancashire Children Looked After (CLA) in Your settings



The PEP is a statutory document that MUST be completed EVERY term to ensure the regular monitoring and review of ALL Lancashire CLA. It is the joint responsibility of the social worker and the setting to produce a thorough, well thought out education plan for the term that meets the

individual child's needs and moves them towards school readiness. **The Autumn term deadline** has now passed.

All autumn PEP meetings for CLA age to 2 years - 4 years should have taken place by now.

- Please check you Portal using this link https://professionalportal.lancashire.gov.uk and the email address used to register the account by the Virtual School and complete any PEPs awaiting your attention. Save the document as you go and save a PDF copy before submitting the document.
- If the PEP meeting has not been arranged, contact the child's social worker and request the meeting is arranged urgently.
- If the meeting has taken place but the form has not been delegated to you, please contact the social worker to request delegation.
- All PEP documentation must be completed and submitted within 2 weeks of the PEP meeting taking place.
- Please state any concerns you have around the child's development and what is being done to support the child within the PEP.

- Please ensure all education targets are SMART (specific, measurable, achievable, relevant and timebound) and that EYPP spending links to the child's targets (EYPP is issued for vulnerable children by the authority based on your termly head count).
- Support and new quality assurance standards can be found at <u>Personal education plans</u> (<u>PEPs</u>) <u>guidance Lancashire County Council</u>.

If you are experiencing technical issues or need to make amendments to your portal account, please contact pepqueries@lancashire.gov.uk as soon as possible for support.

The EYs consultant at the Virtual School is required to attend 1 PEP meeting for all CLA due to start reception in Sept 26. Please email sharie.mayren@lancashire.gov.uk with the date of the next PEP for these children in your setting, or if you require any support.

Starting school is a huge moment for children, especially those who are looked-after (CLA), previously looked-after (PLA) and those who may have a social worker. These children have often experienced multiple adverse childhood experiences (ACEs) or trauma and may need more support with this important transition.

Why do we need to consider this cohort of children?

- These children are likely to be behind their peers during their early years and this gap may widen over time.
- ACEs can affect attendance, learning, behaviour and wellbeing
- In 2018, 50% of children who had a social worker (CWSW) in the last six years were able to achieve GLD at the end of reception compared to 72% who never had a Social Worker
- Children with a Social Worker are more than 3x more likely to be persistently absent from school, and 2-4 times more likely to be permanently excluded

Safeguarding – Continuum of need threshold guidance updated

They work best when used together as the booklet has indicators of what we may notice at each level of need and therefore can be used when we are assessing vulnerability.

Safeguarding – Operation Encompass is rolled out in Lancashire

We are delighted to announce that from **1st December 2025**, Lancashire County Council rolled out **Operation Encompass** to all Maintained, Private, Voluntary and Independent early years settings for children who are taking up Funded Early Education (FEE) places. This important initiative enables us to work together to safeguard and support children who may be experiencing domestic abuse.

What is Operation Encompass? Operation Encompass is a partnership between police and education, designed to ensure that when a child has been exposed to domestic abuse, the setting's Designated Safeguarding Lead (DSL) is notified promptly. This allows you to offer timely and sensitive support to the child, helping to safeguard their wellbeing and development.

Why is this important? Research shows that children who experience domestic abuse can face significant and lasting challenges. By working together, we can make a real difference in their lives, providing the support and care they need to heal and thrive.

All relevant providers have now been emailed instructions on how to sign up so please do this as soon as you can. We will review how things are going early in the new year with a view to Childminders then being able to register for notifications.

Thank you for your continued commitment to safeguarding children in Lancashire. We look forward to welcoming your setting to Operation Encompass and working together to make a positive difference.
