

NOTICE OF PROPOSAL

LANCASHIRE COUNTY COUNCIL

**(ACCRINGTON ROAD, HAPTON, BURNLEY BOROUGH)
(BUS STOP CLEARWAYS)**



NOTICE IS HEREBY GIVEN that Lancashire County Council propose to introduce a Bus Stop Clearway at any time (the effect of which will be to prohibit the stopping of vehicles) in the following lengths of road:

- 1) Accrington Road, Hapton, the west side, from a point 43.9 metres south of its roundabout junction with Bentley Wood Way for a distance of 25 metres in a southerly direction;
- 2) Accrington Road, Hapton, the east side, from a point 42.8 metres south of its roundabout junction with Bentley Wood Way for a distance of 25 metres in a southerly direction;
- 3) Accrington Road, Hapton, the north west side, from a point 336 metres south west of its roundabout junction with Bentley Wood Way for a distance of 25 metres in a south westerly direction;
- 4) Accrington Road, Hapton, the south east side, from a point 368 metres north east of its junction with the centreline of Frontier Way for a distance of 25 metres in a north easterly direction;
- 5) Accrington Road, Hapton, the north west side, from a point 29.7 metres south west of its junction with the centreline of Frontier Way for a distance of 25 metres in a south westerly direction;
- 6) Accrington Road, Hapton, the south east side, from a point 36.3 metres north east of its junction with the centreline of Frontier Way for a distance of 25 metres in a north easterly direction.

Statement of Reasons

The purpose of this proposal is to upgrade the existing bus stops on the A670 Accrington Road at Hapton, with enforceable clearway markings and signs allowing buses to pull in safely and efficiently at the stop.

The proposal intends to promote sustainable transport for all users by including the construction of a raised platform, allowing safe boarding and alighting of passengers.

This proposal is in conjunction with a proposed red route clearway on the A679 Accrington Road Hapton in the vicinity of the new industrial estate.

The proposals are being pursued as part of a s278 Agreement under the Highways Act 1980 as part of a new housing development.
