

**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(VARIOUS LOCATIONS, WYRE BOROUGH) (REVOCATION OF BUS STOP CLEARWAYS)**  
**ORDER 2026**

The County Council of Lancashire ("the Council") in exercise of its powers under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

**1. Revocation**

- a) "The Borough Of Fleetwood (Bus Stops)(Clearway) Order 1974" is hereby revoked in full.
- b) "The Wyre Borough Council (Bus Stops)(Clearway) Order 1983" is hereby revoked in full.
- c) "The Borough Of Wyre (Fleetwood And Thornton Cleveleys) (Bus Stop Clearway) Order, 2001" is hereby revoked in full.
- d) Those parts of the "The Wyre Borough Council (Bus Stops)(Clearway) Order 1986", as set out in Schedule 1a to this Order, are hereby revoked.
- e) That part of the "The Borough Council Of Wyre (Various Roads)(Traffic Regulation)(No.1) Order 1995", as set out in Schedule 1b to this Order, is hereby revoked.
- f) That part of the "The Borough Of Wyre (Various Roads, Cleveleys) Traffic Regulation (No.1) Order 2001", as set out in Schedule 1c to this Order, is hereby revoked.

**2. Commencement of Order**

This Order shall come into force on the 6<sup>th</sup> day of February 2026 and may be cited as the "Lancashire County Council (Various Locations, Wyre Borough) (Revocation Of Bus Stop Clearways) Order 2026".
