

## **SOUTH RIBBLE**

- **Flag Lane, Penwortham** **NEW**

Following an assessment by the bridge owner, Network Rail, concerns have been identified regarding the railway bridge structure.

As a result of these concerns, a request has been received to implement a 7.5t MGW weight limit to control vehicular access to the bridge.
