

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(VARIOUS LOCATIONS, HYNDBURN AND ROSENDALE BOROUGH)
(REVOCATION AND VARIOUS PARKING RESTRICTIONS (25-26 NO3B))
ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the following:
 - a) The "Lancashire County Council (Bacup Road, Mount Avenue, Waterfoot, Todmorden Road, Bacup, Burnley Road East, Water, Rossendale Borough) (Revocation, Prohibition of Waiting and Restriction of Waiting) Order 2016" insofar as it relates to Item 2) of Schedule 3.
 - b) The "Lancashire County Council (Hyndburn Borough Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to Items (6), (11)a and (11)b of Schedule 12.066.
 - c) The "Lancashire County Council (Rossendale Borough Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to Item (85)b)(vi) of Schedule 10.01.
 - d) The "Lancashire County Council (Rossendale Borough Area) (Prohibition Of Stopping On School Entrance Markings) Order 2011" insofar as it relates to Items (9)a and (9)b of The Schedule.
2. Introduce a prohibition of waiting at any time in the following lengths of road:
 - a) Hall Street, Whitworth, Rochdale, the south side, from a point 83 metres west of its junction with the centreline of Spodden Fold for a distance of 27.5 metres in a westerly direction;
 - b) Manchester Road, Accrington, the south west side, from a point 54 metres north west of its junction with the centreline of Langford Street for a distance of 33 metres in a north westerly direction;
 - c) Market Street, Whitworth, Rochdale, the west side, from its junction with the centreline of Station Road for a distance of 176.5 metres in a southerly direction;
 - d) Milnshaw Gardens, Accrington, the north and north east side, from its junction with the centreline of Lupin Road for a distance of 119 metres in a westerly then north westerly direction;
 - e) Milnshaw Gardens, Accrington, the south side, from a point 51 metres west of its junction with the centreline of Lupin Road for a distance of 27 metres in a westerly direction;
 - f) Milnshaw Gardens, Accrington, the south side, from its junction with the centreline of Lupin Road for a distance of 26 metres in a westerly direction;
 - g) Milnshaw Gardens, Accrington, the south west and north west side, from a point 105 metres generally north west of its junction with the centreline of Lupin Road for a distance of 32.5 metres in a north westerly then north easterly direction;
 - h) Milnshaw Gardens, Accrington, the west side, from a point 15 metres east of its junction with the centreline of Lupin Road for a distance of 20 metres in a northerly direction.
3. Introduce a restriction of waiting Monday to Friday 8am – 6pm in Burnley Road East, Waterfoot, Rossendale, the north west side, from a point 121 metres south west of its junction with the centreline of Dean Lane for a distance of 22 metres in a south westerly direction.
4. Introduce a restriction of waiting Monday to Saturday between 8am and 6pm in the following lengths of road:
 - a) Burnley Road, Waterfoot, Rossendale, the south east side, from a point 138 metres south west of its junction with the centreline of Dean Lane for a distance of 17 metres in a south westerly direction;
 - b) Gladstone Street, Bacup, the south west side, from its junction with the centreline of South Street for a distance of 10 metres in a south easterly direction;
 - c) South Street, Bacup, the south east side, from its junction with the centreline of Gladstone Street for a distance of 18 metres in a south westerly direction.

5. Introduce a prohibition of stopping on school keep clear markings Monday to Friday between 8am and 6pm in the following lengths of road:

- a) Burnley Road, Waterfoot, Rossendale, the north west side, from a point 95.5 metres south west of its junction with the centreline of Dean Lane for a distance of 25.56 metres in a south westerly direction;
- b) Burnley Road, Waterfoot, Rossendale, the south east side, from a point 94.5 metres south-west of its junction with the centreline of Dean Lane for a distance of 43.56 metres in a south-westerly direction.
