
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026

**NOTICE IS HEREBY GIVEN** that Lancashire County Council have made an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

1. No person shall cause any motor vehicle to proceed over the following length of highway:
  - a. A577 Ormskirk Road, Up Holland from its junction with Dorchester Road to where it merges with A577 Dingle Road.
  - b. A577 Dingle Road, Up Holland from where it merges with A577 Ormskirk Road to its junction with College Road.
  - c. A577 Parliament Street from its junction with Lafford Lane to where it merges with Church Street.
2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
3. The prohibition will be operative daily from 0930 to 1500 hours on Monday 2<sup>nd</sup> March until Tuesday 31<sup>st</sup> March 2026 or until completion of the works within this period. The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016. Works are weather dependent and may not be carried out on the dates specified. **Access for emergency services will be maintained whenever and wherever possible.**
4. Vehicular access for residents will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.
5. An alternative route for vehicular traffic (except HGVs) affected by the closure is via:-  
A577 School Lane, A577 Orrell Road, B5206 Gathurst Road, B5206 Gathurst Lane, B5206 Shevington Lane, A5209 Crow Orchard Road, A5209 Hall Lane, A5209 Sparrow Hill, A5209 Parbold Hill, A5209 Alder Lane, Higher Lane, Beacon Lane, Mill Lane and vice versa
6. An alternative route for HGVs affected by the closure is via:-  
M58 slip road (westbound) at M6 junction 26, M58 junction 5 from M6 junction 26 off slip road, A577 Stannanought Road, A577 Windmill Road, A577 Newgate Road, Ormskirk Road, Chequer Lane, Tower Hill Road, Hall Green, Alma Hill, Higher Lane

The temporary prohibition is necessary to allow carriageway resurfacing works to be carried out.
