

NOTICE OF PROPOSAL

LANCASHIRE COUNTY COUNCIL

(BURNLEY ROAD, ALTHAM, HYNDBURN BOROUGH) (BUS STOP CLEARWAYS (2500IMG2567 / 2500IMG2568))



NOTICE IS HEREBY GIVEN that Lancashire County Council propose to introduce a Bus Stop Clearway at any time (the effect of which will be to prohibit the stopping of vehicles) in the following lengths of road:

- a) Burnley Road, Altham, the south side from a point 35 metres east of the property boundary of Nos. 1/3 Lane Side Terrace for a distance of 27 metres in an easterly direction.
- b) Burnley Road, Altham, the north side, from a point 47.2 metres east of the property boundary of Nos. 1/3 Lane Side Terrace for a distance of 27 metres in an easterly direction.

Statement of Reasons

This proposal is to support the implementation of accessibility improvements at bus stops within the East Lancashire area. These improvements form part of a wider initiative to provide safe and suitable boarding and alighting facilities for all passengers, including wheelchair users, pushchair users, and individuals with restricted mobility who rely on public transport services.

The introduction and alteration of Bus Stop Clearway markings are necessary to ensure that stopping areas remain free of parked vehicles. Vehicles parking within or adjacent to bus stops can obstruct bus manoeuvring space and limit forward visibility, creating additional difficulties for drivers and for visually impaired passengers. The proposed clearways will therefore provide unobstructed access for buses and support safe and efficient passenger movement.

Where required, additional infrastructure such as bus shelters and raised boarding platforms will be installed to enhance safety, comfort, and accessibility at the stops.

Bus Stop Clearways

**ALTHAM, St James CEPS (by) Stop ID 2500IMG2567; And
ALTHAM, Ambulance Station (by) Stop ID 2500IMG2568**

This proposal will upgrade the existing bus stops to a Quality Bus Stop Clearways, ensuring buses can pull in and out safely and consistently; and

The implementation of the Bus Stop Clearways will ensure that appropriate enforcement measures can be undertaken, thereby improving compliance and delivering benefits for all road users, including pedestrians.
