

NOTICE OF PROPOSAL
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(BURY ROAD AND HASLINGDEN ROAD, RAWTENSTALL, ROSSENDALE
BOROUGH) (REVOCATION, PROHIBITION OF WAITING AND GOODS
VEHICLE LOADING) ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 1, 2 and of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the "Lancashire County Council (Rossendale Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" insofar as it relates to Item (28)a) of Schedule 10.01.
2. Introduce a prohibition of waiting in the following lengths of road:
 - a) Bury Road (A682), Rawtenstall, the north west side, from its junction with the centreline of Bury Road (C701) to its junction with the centreline of the northernmost arm of Haslingden Road (A682);
 - b) Bury Road (A682), Rawtenstall, the south east side, from its junction with the centreline of Bacup Road to a point 21 metres south west of its junction with the centreline of Parramatta Street;
 - c) Bury Road (A682), Rawtenstall, the south east side, from a point 36 metres south west of its junction with the centreline of Parramatta Street to its junction with the centreline of Bury Road (C701);
 - d) Bury Road (C701), Rawtenstall, both sides, from its junction with the centreline of Bury Road (A682) to its junction with the centreline of New Hall Hey Road;
 - e) Haslingden Road (A682), Rawtenstall, both sides, from its junction with the centreline of Bury Road (A682) to its junction with the centreline of the northernmost arm of Haslingden Road (A681).
3. Introduce a good vehicle only loading bay on Bury Road (A682), the south east side, from a point 21 metres south west of its junction with the centreline of Parramatta Street for a distance of 15 metres in a south westerly direction.
