

ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(B6254 KIRBY LONSDALE ROAD, WHITTINGTON, LANCASTER CITY)
(RESTRICTED ROAD 30MPH SPEED LIMIT) ORDER 2014

The County Council of Lancashire, in exercise of its powers under Sections 82(2) and 83(2) of the Road Traffic Regulation Act 1984 as amended ("the Act"), and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. Restricted Road (30mph Speed Limit will apply)

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour along B6254 Kirby Lonsdale Road, Whittington, for a distance of 62 metres in a north easterly direction, from a point 130 metres north east of the centre line of its junction with U49111 Snab Green Lane, which shall become a restricted length of road (as defined in section 82 of the Road Traffic Regulation Act 1984).

2. Exemption

No Speed Limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

3. Commencement of Order

This Order may be cited as the "Lancashire County Council (B6254 Kirby Lonsdale Road, Whittington, Lancaster City) (Restricted Road 30mph Speed Limit) Order 2014" and shall come into force on the 3rd day of March 2014.

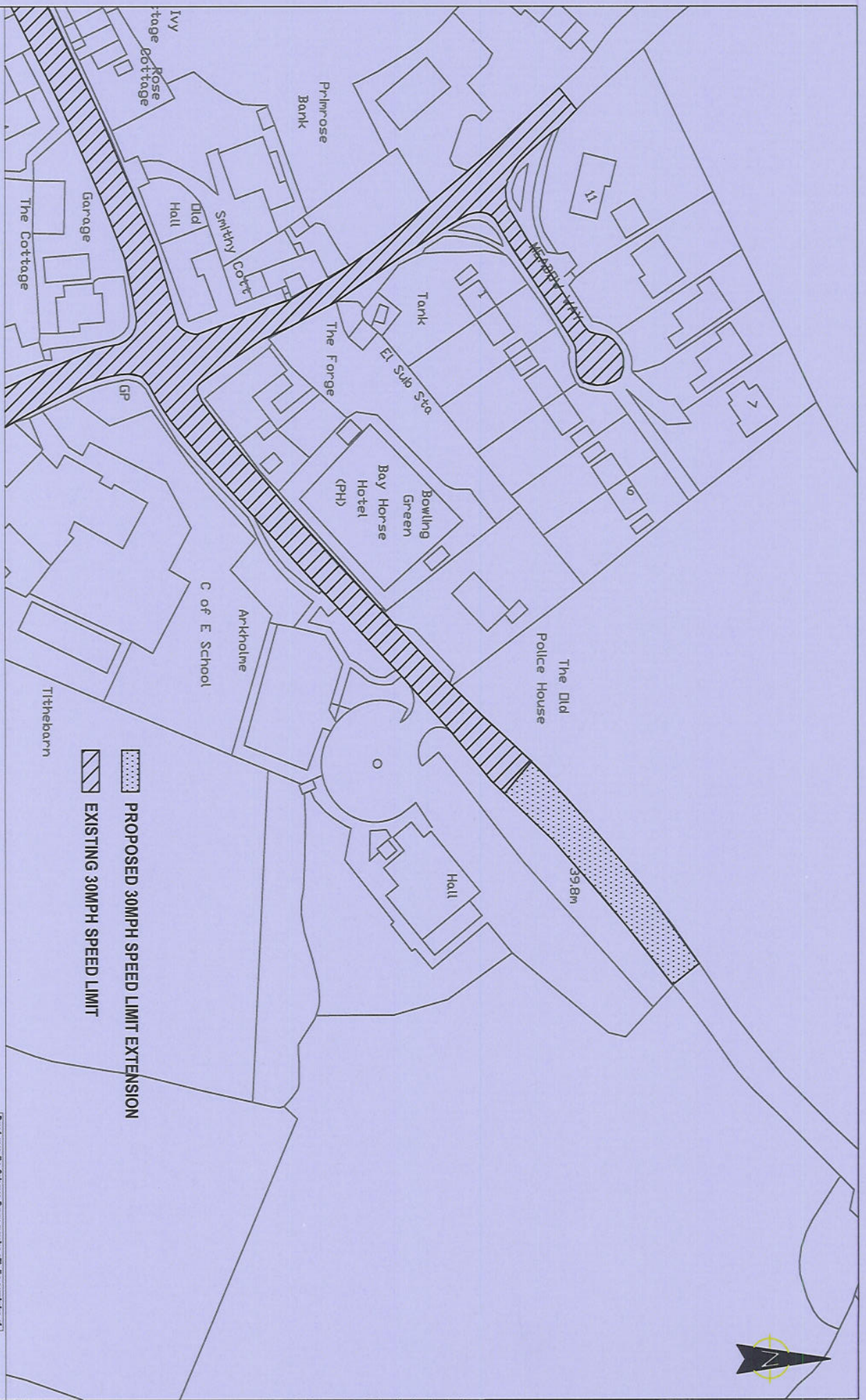
