

**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(VARIOUS LOCATIONS, LANCASTER CITY) (REVOCATION OF RESTRICTED ROADS)**  
**ORDER 202\***

The County Council of Lancashire, in exercise of its powers under Sections 82(2) and 83(2) of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

**1. Revocation**

- a) The "Lancashire County Council (B6254 Kirby Lonsdale Road, Whittington, Lancaster City) (Restricted Road 30mph Speed Limit) Order 2014" is hereby revoked in full.
- b) "The Lancashire County Council (Restricted Roads)(No.4) Order 1984" is hereby revoked in full.
- c) "The City Council of Lancaster (Westgate, Morecambe) (Restricted Road) Order, 1981" is hereby revoked in full.
- d) "The Lancashire County Council (Various Roads, Bolton-le-Sands, Hest Bank and Warton, Lancaster City) (Restricted Roads) Order 1993" is hereby revoked in full.
- e) That part of the "The County Council of Lancaster (Restricted Roads)(No.10) Order 1970", as set out in Schedule 1a to this Order, is hereby revoked.
- f) That part of the "The City Council of Lancaster (Restricted Roads)(No.1) Order, 1978", as set out in Schedule 1b to this Order, is hereby revoked.
- g) That part of the "The City Council of Lancaster (Restricted Roads) (No.1) Order 1981", as set out in Schedule 1c to this Order, is hereby revoked.
- h) Those parts of the "The Lancashire County Council (Various Roads, Yealand Conyers an Yealand Redmayne Villages, Lancaster City) (Restricted Roads) Order 1998", as set out in Schedule 1d to this Order, are hereby revoked.
- i) That part of the "Lancashire County Council (Various Roads, Various Locations, Fylde Borough, Lancaster City and Wyre Borough) (Revocation, Restricted Road, 30, 40 and 50mph Speed Limits) Order 2013", as set out in Schedule 1e to this Order, is hereby revoked.

**2. Commencement of Order**

This Order may be cited as the "Lancashire County Council (Various Locations, Lancaster City) (Revocation Of Restricted Roads) Order 202\*" and shall come into force on the XX day of XX 202\*".
