

LANCASHIRE COUNTY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984
(BARROWFORD ROAD, BURNLEY AND PENDLE BOROUGH'S)
(REVOCATION, 30, 40 AND 50 MPH SPEED LIMITS) ORDER 2012

The County Council of Lancashire, in exercise of its powers under Section 82, 83 and 84 of and Part 1V of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

Those Orders specified in Schedule 1 to this Order are hereby revoked.

2. Restricted Road (30mph Speed Limit will apply)

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour along any part of the length of road referred to in schedule 2, which shall become a restricted Road (as defined in section 82 of the Road Traffic Regulation Act 1984):

3. 40 MPH Speed Limit

No person shall drive any motor vehicle at a speed exceeding 40 miles per hour along any part of the length of road set out in Schedule 3 to this order.

4. 50 MPH Speed Limit

No person shall drive any motor vehicle at a speed exceeding 50 miles per hour along any part of the length of road set out in Schedule 4 to this order.

5. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulation.


6. Commencement of Order

This Order shall come into force on the 10th September 2012 and may be cited as the "Lancashire County Council (Barrowford Road, Burnley And Pendle Borough's) (Revocation, 30, 40 and 50 mph Speed Limits) order 2012"

Schedule 1 - Revocations

Revoke; In full, 'The Borough of Pendle, (Restricted Road) (A6068) Order 1998

Revoke; In full, 'The Lancashire County Council (50 M.P.H Speed Limit) (No.1) Order 1977

Schedule 2 – Introduce Restricted Road (30mph Speed Limit will apply) on:

Barrowford Road, from a point 100 metres west of its junction with Surrey Road to its junction with the A682 Scotland Road, Nelson.

Schedule 3 – Introduce 40mph speed limit on:

Barrowford Road, from a point 175 metres west of its junction with Churchill Road for a distance of 1076 metres in an easterly direction to a point 100 metres west of its junction with Surrey Road.

Schedule 4 – Introduce 50 speed limit on:

Barrowford Road, from its junction with Whalley Road, Padiham, to a point 175 metres west of its junction with Churchill Road.
