

ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(BAWDLANDS AND EDISFORD ROAD, CLITHEROE, RIBBLE VALLEY)
(REVOCATION, 20MPH AND RESTRICTED ROAD) ORDER 2014

The County Council of Lancashire, in exercise of its powers under Sections 82, 83 and 84 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

The "Lancashire County Council (Clitheroe North Area, Clitheroe (Various Roads), Ribble Valley) (20mph Speed Limit) Order 2012" is hereby revoked, insofar as it relates to Bawdlands, B6243.

2. Restricted Road (30mph Speed Limit will apply)

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on B6243 Bawdlands, Clitheroe, from its junction with Henthorn Road, extending onto Edisford road to a point 560 metres west of Lancaster Drive, which shall become a Restricted Road (as defined in section 82 of the Road Traffic regulation Act 1984).

3. 20mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on B6243 Bawdlands, Clitheroe, from its junction with Parson Lane to its junction with Henthorn Road.

4. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.


5. Commencement of Order

This Order may be cited as the "Lancashire County Council (Bawdlands And Edisford Road, Clitheroe, Ribble Valley) (Revocation, 20mph And Restricted Road) Order 2014" and shall come into force on the 20th day of October 2014

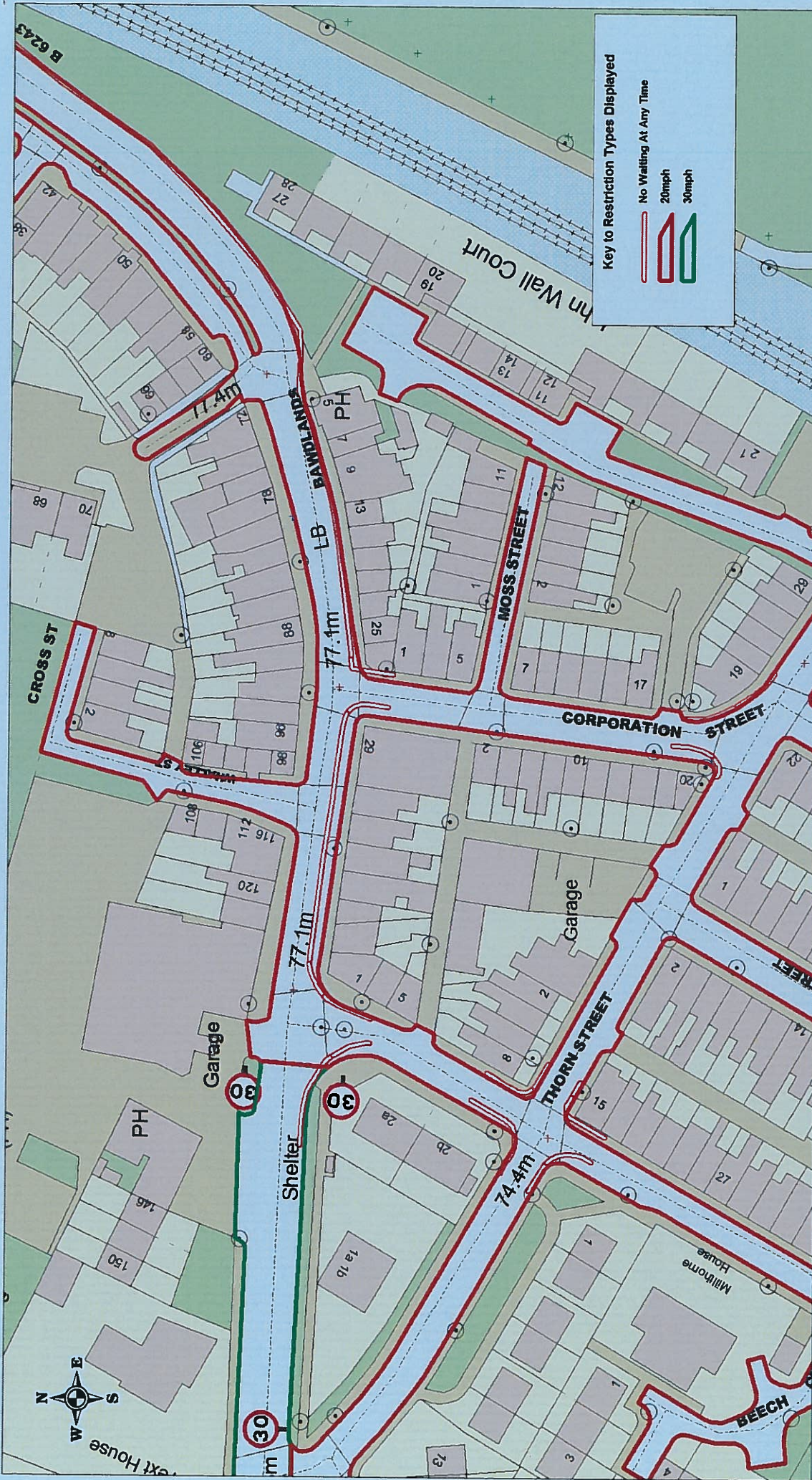

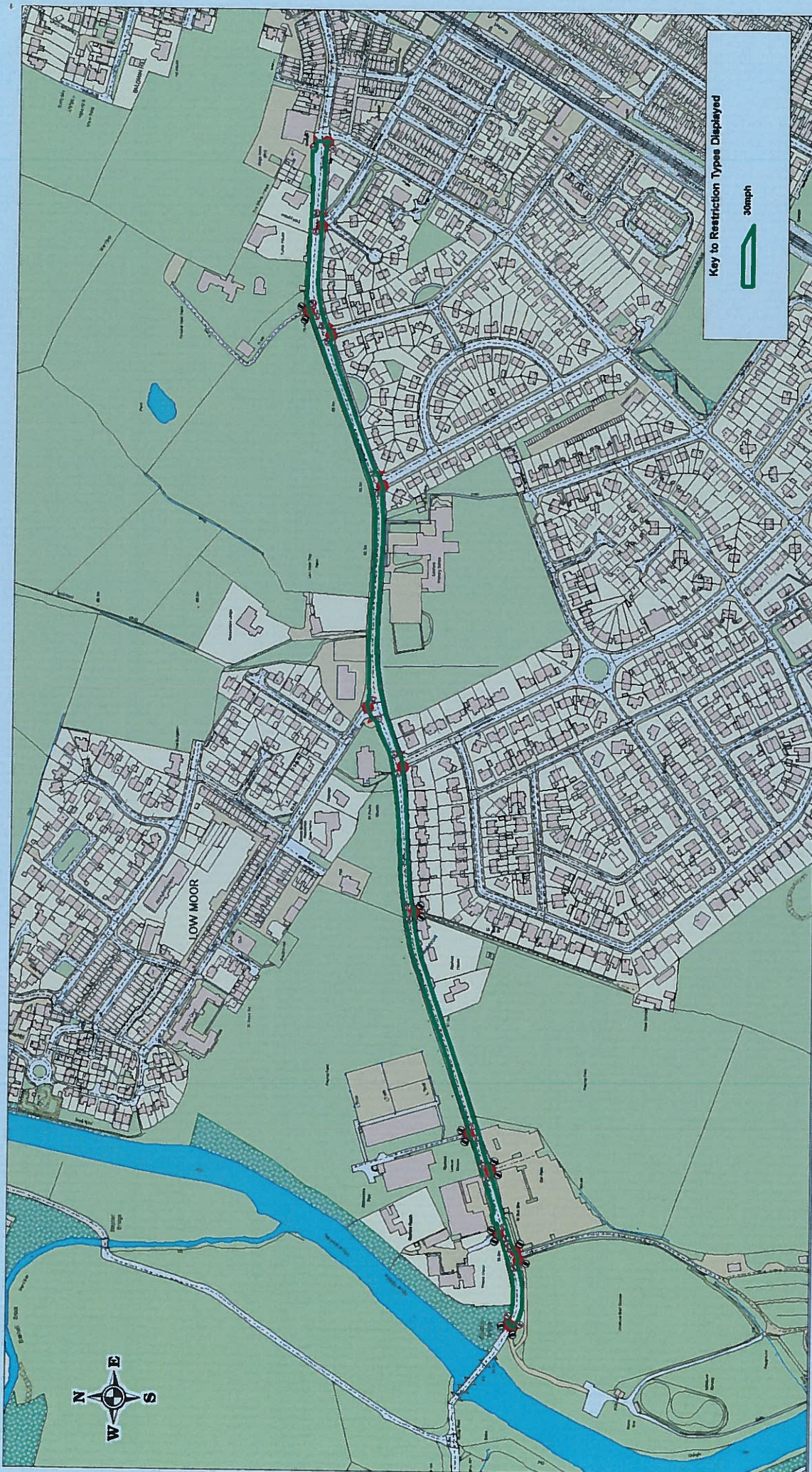

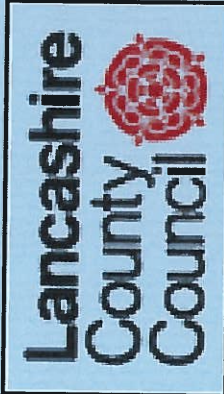
