

NOTICE OF MODIFICATION
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(VARIOUS LOCATIONS, WEST LANCASHIRE BOROUGH)
(REVOCAION OF RESTRICTED ROADS) ORDER 202*



NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2 and 4 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 16th April 2026 and 14th May 2026, it is now intended to modify the proposed Order as titled above, as set out below.

- 1) Remove the following from Article 1. Revocation:
 - a) The "Lancashire County Council (Blaguegate Lane, Skelmersdale and Crosshall Brow, Ormskirk, West Lancashire Borough) (Revocation, Restricted Road and 40mph Speed Limit) Order 2013" is hereby revoked in full.
 - b) The "Lancashire County Council (Cobbs Brow Lane, Cobbs Clough Road and Whalleys Road, Skelmersdale, West Lancashire Borough) (Restricted Road, 30mph and 40mph Speed Limit) Order 2013" is hereby revoked in full.
 - c) The "Lancashire County Council (Higher Lane, Beacon Lane and Hillock Lane, Dalton, West Lancashire Borough) (Restricted Road and 40mph Speed Limit) Order 2012" is hereby revoked in full.
 - d) The "Lancashire County Council (Various Roads, Bickerstaffe, Down Holland, Halsall, Scarisbrick, Aughton and Hesketh Bank, West Lancashire Borough) (Revocation, Restricted Road, 30, 40, 50 and 60mph Speed Limit) Order 2012" is hereby revoked in full.
- 2) Revoke the following:
 - a) Schedule 2 of the "Lancashire County Council (Blaguegate Lane, Skelmersdale and Crosshall Brow, Ormskirk, West Lancashire Borough) (Revocation, Restricted Road and 40mph Speed Limit) Order 2013".
 - b) Article 1 of the "Lancashire County Council (Cobbs Brow Lane, Cobbs Clough Road and Whalleys Road, Skelmersdale, West Lancashire Borough) (Restricted Road, 30mph and 40mph Speed Limit) Order 2013".
 - c) Schedule 1 of the "Lancashire County Council (Higher Lane, Beacon Lane and Hillock Lane, Dalton, West Lancashire Borough) (Restricted Road and 40mph Speed Limit) Order 2012".
 - d) Schedule 2 of the "Lancashire County Council (Various Roads, Bickerstaffe, Down Holland, Halsall, Scarisbrick, Aughton and Hesketh Bank, West Lancashire Borough) (Revocation, Restricted Road, 30, 40, 50 and 60mph Speed Limit) Order 2012".

Statement of Reasons

This modification is due to an administrative error stating the Orders be revoked in full. These should have only included revocations of partial orders as detailed in the schedule.
