

ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(B5269 PRESTON ROAD, INSKIP WITH SOWERBY, WYRE BOROUGH)
(REVOCATION, RESTRICTED ROAD AND 30MPH SPEED LIMIT) ORDER 2014

The County Council of Lancashire, in exercise of its powers under Sections 82, 83, 84 of and Part IV of Schedule 9 of the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Revocation

- a) The 'Lancashire County Council (B5269 Preston Road, Inskip, Wyre Borough) (Revocation and Restricted Road) Order 2000' is hereby revoked in full.
- b) The 'Lancashire County Council (Singleton-Longridge Road, B5269, Inskip, Wyre Borough) (40mph speed limit) Order 1988' is hereby revoked in full.
- c) Schedule 2 and item a) of schedule 3 to the 'Lancashire County Council (Various Roads, Various Locations: Fylde Borough, Lancaster City and Wyre Borough) (Revocation, Restricted Road, 30, 40 and 50 MPH Speed Limits) Order 2013' are hereby revoked.

2. Restricted Road (30mph Speed Limit will apply)

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the B5269 Preston Road – Mill Lane – Preston Road, Inskip-with-Sowerby, from a point 26 metres east of the junction with Pinfold Lane, in an easterly then south easterly direction to a point 600 metres south east of Higham Side Road junction for a distance of 1480 metres, which shall become a restricted road for the purposes of Section 81 of the Road Traffic Regulation Act 1984.

3. 30mph Speed Limit

No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the B5269 Preston Road, Inskip-with-Sowerby, from a point 26 metres east of the junction with Pinfold Lane for a distance of 978 metres in a westerly direction.

4. Exemption

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

5. Commencement of Order

This Order will come into force on the 10th day of November 2014 and may be cited as the "Lancashire County Council (B5269 Preston Road, Inskip With Sowerby, Wyre Borough) (Revocation, Restricted Road And 30mph Speed Limit) Order 2014.

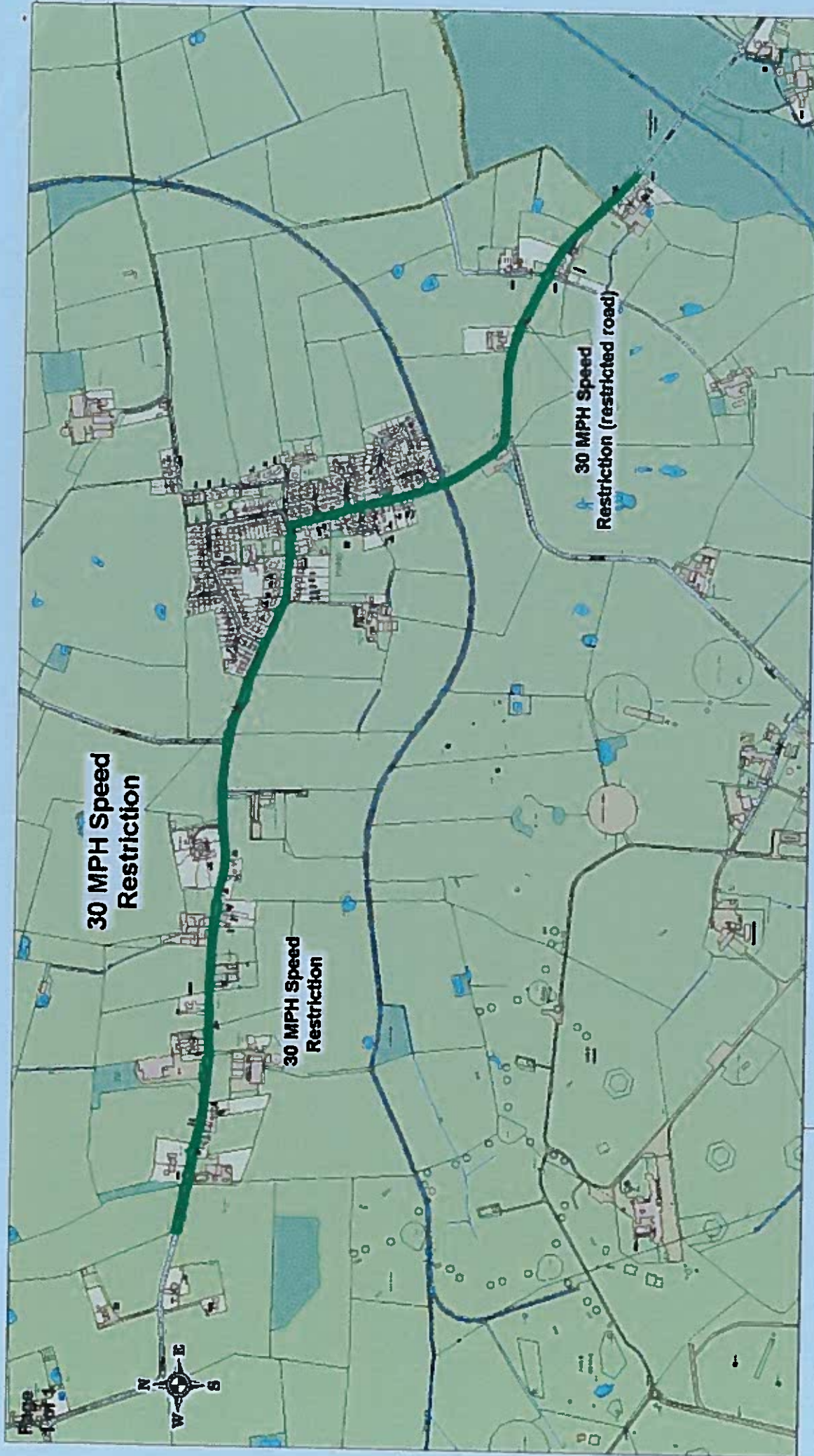
