I am writing further to your letter dated 11 February.

As you are aware I act on behalf of the objector, Lancashire County Council as Landowner.

Please be advised that the Landowner is disappointed with the decision to make the Order, however notes that the matter is to be reported back to Regulatory Committee at a later date regarding the promotion of the Order to confirmation.

I note that the deadline is 1 April however, enquiries with the Landowner (Mr Guy) of land south of and communicating with point E has been protracted due to difficulty in making contact. The landowner has recently been informed that Mr Guy has unfortunately passed away. This means that the Landowner is having to make title investigations, first by paper to determine current Landowner and obviously further discussions will need to take place including a site visit.

Whilst I can confirm the Landowner objects to the making of the Order, in view of the above it may be that evidence cannot be collated and an objection settled by 1 April.

Please can you confirm that the OMA notes the Landowner's objection and further agrees to receiving evidence as soon as possible after 1 April.
