

NOTICE OF MODIFICATION
ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(VARIOUS LOCATIONS, FYLDE BOROUGH) (REVOCATION AND
VARIOUS PARKING RESTRICTIONS (25-26 NO3H)) ORDER 202*



NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 5th March 2026 and 2nd April 2026, it is now intended to modify the proposed Order as titled above, as set out below.

- 1) Remove the following from Schedule 7 - Limited Waiting Parking Place 1 Hour No Return Within 1 Hour Monday to Saturday 8am – 6pm:
 - f) Henry Street, Lytham St Annes, the north side, from a point 4.5 metres east of its junction with the Centreline of Green Street for a distance of 48 metres in an easterly direction.
- 2) Introduce a limited waiting parking place for 1 hour with no return within 1 hour Monday to Saturday between 8am and 6pm in Henry Street, Lytham St Annes, the north side, from a point 29 metres east of its junction with the Centreline of Green Street for a distance of 23.5 metres in an easterly direction.
- 3) Introduce a limited waiting parking place for 1 hour with no return within 1 hour between 8am and 6pm in Henry Street, Lytham St Annes, the north side, from a point 4.5 metres east of its junction with the Centreline of Green Street for a distance of 24.5 metres in an easterly direction.

Statement of Reasons

Having considered the responses and feedback following the formal consultation, it is intended to make a modification to the proposed parking restrictions on Dicconson Terrace and Henry Street, Lytham St Annes.

The proposals will ensure that the Traffic Regulation Order matches the existing road markings already historically in situ and to improve the consistency and clarity of signage within the area to better manage parking demand.

Following a request for Sunday restrictions, we propose the following modification to retain the only existing Sunday restriction:

- 5-11 Henry Street Bay: Limited waiting, 8am-6pm, 1 hour no return within 1 hour.

All remaining restrictions would remain unaltered, continuing to apply limited waiting Monday to Saturday only.
