

**ROAD TRAFFIC REGULATION ACT 1984**

**LANCASHIRE COUNTY COUNCIL**

**(VARIOUS LOCATIONS, FYLDE, WEST LANCASHIRE AND ROSSENDALE) (REVOCATION 20MPH, 30MPH AND 40MPH SPEED LIMITS (26-27 NO1)) ORDER 202\***

The County Council of Lancashire, in exercise of its powers under 83(2) and Section 84 and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

**1. Revocation**

- 1) The "Lancashire County Council ( Meadows Avenue Area Zone, Haslingden, Rossendale Borough) ( 20mph Speed Limit) Order 2007" is hereby revoked in full.
- 2) "The Lancashire County Council Moss Lane (Also Known As Straight Up Lane) And Wyke Lane, North Meols, West Lancashire District-Restricted Roads Order 1997" is hereby revoked in full.
- 3) Those parts of the "Lancashire County Council (Various Roads In Roseacre, Treales And Wharles, Fylde Borough) (Restricted Road And 40mph Speed Limit) Order 2003", as set out in Schedule 1a to this Order, are hereby revoked.
- 4) Those parts of the "Lancashire County Council (Various Roads, West Lancashire Borough) (Part Revocation, Restricted Road 30mph, 30mph And 40mph Speed Limit) Order 2017", as set out in Schedule 1b to this Order, are hereby revoked.

**2. 20mph Speed Limit**

No person shall drive any motor vehicle at a speed exceeding 20mph on the length of road as set out in Schedule 2 to this Order.

**3. 30mph Speed Limit**

No person shall drive any motor vehicle at a speed exceeding 30mph on any of the lengths of road as set out in Schedule 3 to this Order.

**4. 40mph Speed Limit**

No person shall drive any motor vehicle at a speed exceeding 40mph on the length of road as set out in Schedule 4 to this Order.

**5. Exemption**

No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those Regulations.

## **6. Commencement of Order**

This Order shall come into force on the \*\* day of \*\* 202\* and shall be cited as the "Lancashire County Council (Various Locations, Fylde, West Lancashire And Rossendale) (Revocation 20mph, 30mph And 40mph Speed Limits (26-27 No1)) Order 202\*".

### **Schedule 2 - 20mph Speed Limit**

Goodshaw Lane, Crawshawbooth, Rossendale, for the entire length.

### **Schedule 3 - 30mph Speed Limit**

- a) Barrow Nook Lane, Bickerstaffe, from its junction with Coach Road for a distance on 53 metres in a north westerly direction;
- b) Carr Lane, Treales, Roseacre and Wharles, from its junction with Kirkham Road for a distance of 137 metres in a southerly direction;
- c) Church Road, Treales, Roseacre and Wharles, from its junction with Kirkham Road for a distance of 96.5 metres in a northerly direction;
- d) Lyelake Lane, Bickerstaffe, for the entire length;
- e) The Orchard, Treales, Roseacre and Wharles, for the entire length;
- f) Treales Road, Treales, Roseacre and Wharles, from its junction with Moss Lane West for a distance of 100 metres in a south easterly direction;  
Wyke Lane, Banks, from its junction with Moss Lane for a distance of 180 metres in a south easterly direction.

### **Schedule 4 - 40mph Speed Limit**

Wiggins Lane, Holmeswood, from a point 260 metres south west of its junction with Holmeswood Road to its junction with Berry House Lane.
