

ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(VARIOUS LOCATIONS, PRESTON, HYNDBURN, BURNLEY AND ROSSENDALE) (VARIOUS
MOVING RESTRICTIONS 26-27 NO1) ORDER 202*

The County Council of Lancashire ("the Council") in exercise of its powers under Sections 1, 2 and 4 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. Definitions and Interpretation

For all the purposes of this Order the terms described in this Article shall have the meanings specified:

"Vehicle" means a motor vehicle, a passenger vehicle, a dual-purpose vehicle, a goods vehicle, a motorcycle or an invalid carriage or any other vehicle of any description whether drawn or propelled along a road by animal or mechanical power.

2. Revocation

"The Borough of Preston (York Avenue, Withy Parade and Empress Avenue) (Access Only) Order 1990" is hereby revoked in full.

3. 7.5 Tonne Weight Restriction

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any Vehicle, the weight of which exceeds 7.5 tonnes, to enter or proceed along the length of road set out in Schedule 1 to this Order.

4. 7 Metre Length Restriction

Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any Vehicle, the length of which exceeds 7 metres, to enter or proceed along the length of road set out in Schedule 2 to this Order.

5. Prohibition of Driving

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any Vehicle, to proceed along the lengths of road referred to in Schedule 3 to this Order.

6. One Way Traffic Restriction

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any Vehicle, to enter or proceed along the length of road set out in Schedule 4 to this Order, in any direction other than that specified.

7. Exemptions to Articles 3, 4, and 5

Nothing in Articles 3, 4 and 5 of this Order shall render it unlawful to cause or permit any Vehicle to travel along any part of the lengths of road referred to therein for so long as may be necessary to enable:

- a) the Vehicle to be used for fire brigade, ambulance or police purposes in pursuance of statutory powers or duties;
- b) the Vehicle to be used for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road;
- c) if the Vehicle is being used in connection with the carrying out, or on premises situated on or adjacent to that length of road, of any of the following operations namely:
 - i) building, industrial or demolition operations;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said lengths of roads;
 - iv) the laying, erection, alteration or repair in or in land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus or the exercise of any other statutory power or duty for the maintenance and supply of gas, water or electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984.

8. Exemptions to Articles 3 and 5

Nothing in Articles 3 and 5 of this Order shall render it unlawful to cause or permit any Vehicle to travel along any part of the lengths of road referred to therein for so long as may be necessary to enable access to any premises situated on or adjacent to the road.

9. Exemptions to Article 6

Nothing in Article 6 of this Order shall render it unlawful to cause or permit any Vehicle to travel along any part of the lengths of road referred to therein for so long as may be necessary to enable:

- a) the Vehicle to be used for fire brigade, ambulance or police purposes in pursuance of statutory powers or duties;
- b) the Vehicle to be used for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road;
- c) the Vehicle, if it cannot conveniently be used for such purpose in any other road to be used in connection with the removal of any obstruction to traffic.

10. Miscellaneous

The prohibitions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act or by or under any other enactment.

11. Commencement of Order

This Order shall come into force on the ***** 202* and may be cited as the “Lancashire County Council (Various Locations, Preston, Hyndburn, Burnley And Rossendale) (Various Moving Restrictions 26-27 No1) Order 202*”.

Schedule 1 – 7.5 Tonne Weight Restriction

Goodshaw Lane, Crawshawbooth, for the entire length.

Schedule 2 – 7 Metre Length Restriction

Blackleach Lane, Preston, from a point 152 metres west of its junction with Catforth Road for a distance of 16.5 metres in a southerly direction.

Schedule 3 – Prohibition of Driving

- a) Back 179 to 197 Garstang Road, Preston, for the entire length.
- b) Empress Avenue, Preston, for the entire length.
- c) Withy Parade, Preston, for the entire length.
- d) York Avenue, Preston, for the entire length.

Schedule 4 – One Way Traffic Restriction

- a) Cobden Street, Burnley, from its junction with Briercliffe Road to its junction with Cleaver Street, in a south-easterly direction.
- b) St Cecilia Street, Great Harwood, from its junction with St Huberts Street to its junction with Cross Street in a north easterly direction.
