Section 10 – Tax Free Childcare

As a setting, we offer the free funded hrs 15 and 30hrs.

We also offer Child Tax Free Childcare. This is where the parent sets an account up on the government website, adding my details. For every £8 a parent pays into this, the government top this up with £2. This scheme can save up to £2000 a year and can be used alongside the free hrs if eligible for both.

If claiming universal credits, you could also be eligible for up to 80% of your childcare costs (depending on income)
